**PROVISIONAL BALLOTS**


A Voter is only to vote by Provisional Ballot at his/her proper polling place if **1)** the Voter claims to be registered in that election district and is not in the Poll Book; **2)** the Voter moved outside of his or her registered election district, but within the county, without informing the Commissioner of Registration; **3)** the Voter is in the poll book but is noted as having been sent a Mail-In Ballot; **4)** the Voter is in the Poll Book but is marked as “ID required” and the Voter does not have the required ID. Other than these exceptions, a Voter who is qualified to vote by voting machine does not have the option of choosing to vote by Provisional Ballot. The Voter must vote in the voting machine at the Voter’s proper Polling Place. If you are unsure if the Voter should vote by a Provisional Ballot, please call Board of Elections at 973-285-6715.

**NEW For This Election!**

This election you will notice that there are Moist Towelettes (wet naps) enclosed in the Key Envelope. These towlettes are to clean the Mylar Screen if a Voter writes on it. If you have any questions call the Voting Machine Warehouse at 973-285-6741.

**ID REQUIRED PRINTED IN VOTER’S SIGNATURE BOX**

A Voter must show identification **ONLY** when it is indicated in the Voter’s Signature Box in the Poll Book. (see example below)

**CAN'T FIND VOTER'S NAME?**

If the Voter’s name is not in poll book and does not appear on the Alpha List, before you turn the Voter away, PLEASE CALL THIS OFFICE at 973-285-6715 to verify if the person is registered to vote.

## CHALLENGER'S CERTIFICATE AND BADGES

Challengers are appointed to observe the conduct of an election on behalf of a candidate, a political party or the proponents or opponents of a question. The primary duty of a Challenger is to observe the election, keep a record of who voted, and challenge any voter for whom they have a reasonable basis to believe is not qualified to vote.

Challengers are required to give the Permit letter (example #1) of their challenger credentials to the Poll Worker. Challengers need to keep the badge portion (example #2) with them at all times, wearing the badge inside the polling place.

<small>(This permit must be presented by the person named herein to the election board of the district named herein, and he/she shall then be permitted to remain within the polling place while the election is in progress, and to be within the railed enclosure while the ballots are being counted - 19:7-1 to 19:7-5.)</small>		
<b>BRIAN HAMILTON</b> , having presented to the County Board of Elections of the county of MORRIS State of New Jersey, a paper under the hand of		
GARRETT SCHUBERT, Candidate		
appointing him as one of two Agents or Challengers to represent the said GARRETT SCHUBERT, in Election District MOUNT OLIVE TOWNSHIP-00-10 in the Township of MOUNT OLIVE TOWNSHIP County of MORRIS, State of New Jersey, at the General to be held on 11/07/2017.		
The said BRIAN HAMILTON is hereby permitted to act as such Agent or Challenger at the election in said Election District, in accordance with the law of this state.
