**RESOLUTION AWARDING CONTRACT FOR LANDSCAPING AT  
MORRIS MEWS, PLEASANT VIEW VILLAGE, PEER PLACE, BENNETT AVENUE,  
GREEN POND VILLAGE AND INDIA BROOK VILLAGE**

WHEREAS, the Housing Authority of the County of Morris has solicited bids for Landscaping at Morris Mews, Pleasant View Village, Peer Place, Bennett Avenue, Green Pond Village and India Brook Village, in accordance with the New Jersey Public Contract Law; and

WHEREAS, the bids were accepted in accordance with specifications prepared by the Housing Authority and read aloud at 10:30 A.M. on September 28, 2018 at the offices of the Housing Authority of the County of Morris, located at 99 Ketch Road, Morristown, New Jersey; and

WHEREAS, **LTI Landscaping** is the lowest responsible bidder for Morris Mews, Pleasant View Village, Peer Place, Bennett Avenue, Green Pond Village and India Brook Village **for a total cost of \$59,300**; and

WHEREAS, the Board of Commissioners of the Housing Authority of the County of Morris findings are attached; and

WHEREAS, funds are available from the US Department of Housing and Urban Development and USDA Rural Development; and

WHEREAS, the Housing Authority desires to accept the bid from **LTI Landscaping**; and

WHEREAS, the Housing Authority of the County of Morris finds that the best interests of the Authority and the purpose of the New Jersey Local Public Contract Law would be served by awarding the contract to the lowest responsible bidder.

NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of the Housing Authority of the County of Morris hereby approves the award of the landscaping contract for Morris Mews, Pleasant View Village, Peer Place, Bennett Avenue, Green Pond Village and India Brook Village to **LTI Landscaping for the period of April 1, 2019 to December 31, 2019.**
