
D.1 CITIZEN SURVEY



This section contains information and results gathered from the Morris County Citizen Survey. The main objective of this survey was to gather information from citizens regarding their level of knowledge regarding hazard vulnerability and knowledge of hazard mitigation information for their local communities. The survey was available on the Morris County OEM's HMP website beginning in the early fall of 2019. County departments and several municipalities also posted the survey on their websites and social media as shown in the figures below.

A total of 228 respondents completed this survey through June 2020. Respondents primarily consisted of individuals who have lived in Morris County for 20 years or more and live in a single-family home. Survey respondents indicated they are most concerned regarding severe winter storms, severe weather and flooding. Survey respondents identified mitigation projects to reduce the effects of hazards include retrofit infrastructure; improve damage resistance to utilities and install and improve protective structures. The Citizen Survey results are included at the end of this appendix.

D.2 PUBLIC MEETINGS

All Planning Partnership meetings were open to the public. Meetings were advertised on the Morris County OEM HMP website as well as through social media platforms. One resident attended the September 2019 Planning Partnership Kickoff meeting. This feedback was provided back to the County and municipalities to consider incorporation into the plan.

On September 14, 2019, the Township of Pequannock hosted its annual Hoedown. The Township’s Flood Resilience Officer was available at a table to engage with residents, discuss the flood hazard, and had the HMP brochure available for distribution. A total of 17 residents signed-in at the table.

Morris County and the planning consultant attended the public event, Morristown on the Green on September 29, 2020 in the Town of Morristown. A table set up with Morris County Office of Health Management to distribute information on the HMP and engage with residents and businesses regarding the plan and mitigation. The HMP brochure in English and Spanish was available, as well as an abbreviated version of the citizen survey (8 questions) with a QR code for residents to take the 5-minute survey on their phone; refer to Figure D-2.

An interactive mitigation strategy voting exercise was available for residents to take while visiting the mitigation table at this public event. The planning consultant asked residents what mitigation strategy they preferred implemented to reduce natural hazard risk in their community; the four FEMA mitigation strategy types were given as choices. Figure D-3 summarizes these results. A total of 45 residents participated in the survey with a majority selecting natural systems protection (18 votes) followed by structure and infrastructure projects (15 votes).

Ultimately, all 39 Morris County municipalities benefit from being eligible for federal funding. Hazard Mitigation is defined as any action taken to reduce the loss of life and property by lessening the impact of disasters. These disasters could include floods, severe storms, and extreme temperatures, among many others. Public participation and feedback is a vital part of the hazard mitigation planning process. In addition to asking residents to attend key meetings, Morris County also has developed a Citizen Preparedness Survey to assist in providing the public an outlet to contribute to the 2020 HMP update. D.4 STAKEHOLDER SURVEYS

Morris County distributed online surveys to stakeholders in an effort to gather additional capabilities, vulnerabilities and mitigation projects in the County and region. In order to gather that information during the COVID-19 pandemic, the surveys were sent to the following stakeholders: emergency services (law enforcement, firefighters, emergency medical services), transportation agencies and public works, business and commerce, hospitals and health care providers, social services, academia and utilities. A total of 70 responses were submitted across all sectors; refer to Figure D-5. Results of the surveys are provided at the end of this appendix, with personal information redacted. A summary of entities that the surveys were distributed to, and those that responded may also be found in Section 2 (Planning Process).

Figure D-5. Number of Stakeholder Survey Responses by Sector






Figure 0-10. Township of Pequannock Website Announcement for the HMP Citizen Survey








Figure D-21. Long Hill Township Twitter Post Regarding the HMP Citizen Survey






Figure D-22. Morris Herald-News HMP Twitter Post






Figure D-23. Morris Plains Police Department Twitter Post Regarding the HMP Update and Citizen Survey






















