### PRIMARY ELECTION

#### REMINDER OF PARTY AFFILIATION RULES

**CAN A VOTER VOTE IN A PRIMARY ELECTION IF THEY HAVE NOT DECLARED A PARTY PRIOR TO ELECTION DAY?**

Yes, if the registered voter is unaffiliated he/she must complete a Pink or Blue First Time Party Affiliation at their polling place on the day of the Primary Election. This declaration must be made before the voter is permitted to vote. From Election Day on, the voter will be affiliated with that political party until he/she notifies this office of a change at least **55** days prior to the next Primary Election.

**IN A PRIMARY ELECTION CAN A VOTER CROSS PARTY LINES AND VOTE FOR A CANDIDATE FROM THE OTHER PARTY?**

No, in the Primary Election the voter can only vote the party in which he/she is affiliated with. In order to change your party affiliation, the voter must file a written request with the Board of Elections Office at least **55** days before the Primary Election. Once the voter changes parties, he/she will be affiliated with the new party for the next Primary Election.

**The General Election is the only time a voter can cross party lines.**

#### IMPORTANT POLL WORKER POINTS

- ⇒ Majority of Court Orders issued to Voters are to Vote on the Voting Machine at their assigned polling location.
- ⇒ Poll Workers should point out to the voter exactly where to sign in the Poll Book.
- ⇒ **"No Signature on File"** in Signature Box. There is no signature to compare, the Voter Votes by Provisional Ballot.
- ⇒ Poll Workers can ONLY ask a Voter for ID when **"ID Required"** is printed in Signature Box and or if the Voter is being Challenged by an appointed Challenger.
