### **PRIMARY ELECTION**

### REMINDER OF PARTY AFFILIATION RULES

CAN A VOTER VOTE IN A PRIMARY ELECTION IF THEY HAVE NOT DECLARED A PARTY PRIOR TO ELECTION DAY?

Yes, if the registered voter is unaffiliated he/she <u>must complete a Pink or</u> <u>Blue First Time Party Affiliation at their polling place on the day of</u> <u>the Primary Election.</u> This declaration must be made before the voter is permitted to vote. From Election Day on, the voter will be affiliated with that political party until he/she notifies this office of a change at least 55 days prior to the next Primary Election.

# IN A PRIMARY ELECTION CAN A VOTER CROSS PARTY LINES AND VOTE FOR A CANDIDATE FROM THE OTHER PARTY?

No, in the Primary Election the voter can only vote the party in which he/she is affiliated with. In order to change your party affiliation, the voter must file a written request with the Board of Elections Office at least **55** days before the Primary Election. Once the voter changes parties, he/she will be affiliated with the new party for the next Primary Election.

The General Election is the only time a voter can cross party lines.

#### IMPORTANT POLL WORKER POINTS

- ⇒ Majority of Court Orders issued to Voters are to <u>Vote on the Voting Machine at their assigned polling location.</u>
- ⇒ Poll Workers should point out to the voter exactly where to sign in the Poll Book.
- ⇒ "No Signature on File" in Signature Box. There is no signature to compare, the Voter Votes by Provisional Ballot.
- ⇒ Poll Workers can <u>ONLY</u> ask a Voter for ID when "ID Required" is printed in Signature Box and or if the Voter is being Challenged by an appointed Challenger.
