Meeting open to public: Opened at 6:03PM. No member of the public wished to speak. Closed to the public at 6:04PM.

Correspondence: Executive Director Kelly A. Stephens included a thank you from a realtor/family member, thanking the Housing Authority for all their efforts in housing a family that was homeless. This was a true collaborative effort between herself, the HCV staff, Office of Temporary Assistance, Family Promise and the family themselves.

Committee Report: Executive Director Stephens reported the Finance Committee will need to meet at the end of September or first week in October to discuss the 2024 budget and introduce it at our October meeting. The Personnel Committee will be meeting sometime in October to follow-up items from the last meeting.

Chairman Report: None.

Executive Director Report: Executive Director Stephens reported the activities for the month included chair exercise, quarter exchange, blood pressure screenings, food pantry, foot doctor and cook outs at senior buildings.

On Tuesday, she will be attending a press conference in Montclair for Congresswoman Mike Sherill as she highlights the reintroduction of the Homeless Children and Youth Act. On September 15th, there will be an event at Executive Drive for Municipal Leaders to learn about the various non-profits and the Continuum of Care.

The Housing Authority received notification from the software company that the applicant portal will be retired by the end of the year. We are updating the portal which will allow applicants to make changes and upload documents. The Housing Authority is also adding a tenant portal where tenants/participants can complete their annual recertification process, upload documents, message caseworks, enter work orders and make payments. Lastly, the landlord portal will enable landlords to access inspections, payments and 1099's.

eviction. Day Pitney also provided assistance regarding the dryer vent resolution and a question about prevailing wage. They also provided guidance regarding law enforcement and releasing a client's personal information.

<u>Old Business</u> – Regarding the PVV Property, there are no compliance concerns regarding the actual property or development. Executive Director Stephens will be meeting with the tenants of the building, and she will need to attend a Town Council meeting to submit to HUD for approval.
