#### **New Business**

Anthony and Ralph Polcari were invited to join in this meeting to answer any questions regarding the Audit, Budget and for a brief synopsis of the Rental Assistance (RAD).

Anthony Polcari went into great depth about the Audit. One of the main issues is the OPEB liability must now be on the books, which shows an unrestricted net position deficit. This is not an issue with just Morris County, but Housing Authorities all over NJ and the country. Anthony Polcari suggested that the unaudited year end financials be distributed to the Board for their review in March so they are aware of any issues early on.

Anthony Polcari also provided an explanation of the Rental Assistance Demonstration (RAD) Program. A Personal Needs Assessment would need to be completed of the properties by an Architect/Engineer and a 15-year cash flow projection. There are templates to conduct a preliminary analysis. HUD is pushing for all Housing Authorities to transfer to the RAD program but we are unclear as to the timeline. Anthony Polcari pointed out that RAD would not help with the pension deficits. In addition, there is no operating subsidy or CFP with RAD.
