County Alliance Steering Subcommittee (CASS) – Ms. Amy Archer

Ms. Archer stated that at this time funding is currently frozen and there will not be payment for any new activities as of March 23, 2020. How this will effect the upcoming funding cycle has not been determind.

Addictions Services Coordinator – Ms. Rosalyn Suarez

Mrs. Suarez reported the Morris County Innovations Grant has been approved. The resolution will be going to the next Freeholder's meeting on May 27. The Request For Proposal (RFP) will be posted soon and providers can check BidNet for submission.

Mental Health Administrator – Ms. Amy Archer

Ms. Archer provided the following update to the County's Covid-19 efforts:

- May is Mental Health Awareness Month. Resources and reference guides are countinously being updated on the website at https://morriscountynj.gov/.
- The Warming Center was extended through May 31, so that will be coming to an end soon
- Handwashing station were placed in Dover and Morristown.

Joint PAC Report – Ms. Lynn Chandler

Ms. Chandler reported with the implementation of Telehealth, providers are seeing positive response from those clients that typically cancel in-person appointments and they are now keeping their virtual appointments.

Ms. Carol DeGraw asked if the Children's Mobile Response is still operating. Ms. Chandler stated yes, but is underutilized statewide and the community may not me aware of this service.

HSAC Report – Ms. Jane Shivas

Ms. Shives reported the State Comprehensive Needs Asseccement is temporarily on hold.

Child Care for essential workers was extended to the end of May.

Work Force Development is working remotely. Due to the massive increase in claims this has caused delays with receiving unemployment benefits. It is expected that 45% of small busenesses will file forbankruptcywhich could trigger another wave of unemployment claims.

Old Business

Ms. Suarez provided a Stigma Free update. Wharton does not want to pass the resolution to be Stigma Free. However, they have been doing Stigma Free activities. The following townships are still not Stigma Free; Wharton, Harding, Riverdale, and Florham Park. The next Stigma Free meeing will be May 19 at 2:00 pm via ZOOM.

Ms. DeGraw provided the following information about the ALICE Fund; 186 applications have been processed to date with a payout of \$250,000, 59 applications going to the Review Committee on May 15 totalling \$84,000 and over 800 applications still need be looked at.

New Business

Ms. Linda Csengeto stated that Greystone has reported 107 staff members and 47 residents have tested positive for Covid-19 and 7 deaths have been reported.
