COC Orientation:

- COC Basics: (David Saltzman) Explained what is a COC?, Mission Statement and Purpose
- Definitions: (Ashni Matthew) Homelessness, Housing First and Diversion

Notes from Allison:

- 1. COC describes multiple things. Every aspect of continuum of care. Services and access to services. Schools through aging services, nursing homes, law enforcement, schools, etc. Executive Committee: also does funding. We fund specific things. We do not fund emergency shelters, but we do have them under our umbrella.
- 2. Homelessness definition: consumers are doubling up in our communities. Individuals also are trading for housing. Chronic homelessness is prioritized.
- 3. Housing First: 2021 allocation process put an emphasis on programs who provide Housing First.

Lead Agency is County of Morris. Amy explained how they support COC. Also explained how Human Services Advisory council, Community Development, Monarch Housing Associates, and HMIS supports COC.

<u>Community Assistance Services</u>: (CAS) Allison went over details of CAS, role and subcommittees. Allison shared the Morris County CAS website and explained Point In Time Count 2022 System Performance: Allison explained there are two You Tube training videos on the webpage

Coordinated Entry: Maria Fodali explained the process, steps they consumers need to go through, structure and partners.

Lived Experience Advisory Board: Ashni Matthew discussed what they did in 2021 and what their 2022 goals are. Statistics of racial disparities were shared.

Permanent Housing Subcommittee: Jeff Bashe went over the barriers and purpose of committee and current projects.

<u>2022 COC Priorities</u>: Allison went over structure changes:

- Converting "racial equity task force" to a "diversity and inclusion committee"
- Converting "planning workgroup" to a standing committee
- Combining "provider resource committee" and "every day connect committee"
- Moving "Program Coordinating Committee" under the purview of the Permanent Housing Committee and strengthening formal relationships with public housing authorities.
- Moving Veterans under Coordinated Entry and a case conferencing team.

- Bringing more people with lived experience
- Strengthening relationship for Code Blue participants

- Housing Authorities
- Housing Alliance
- Hope Suite (Hope Hub meeting) (Sherriff's office)
- Fair Housing committee

Data Driven and Specific: to monitor programs performance and score funding applications, solutions, create standards, better tools,

2022 COC Priorities: On the Horizon:

- Enhance COC administrative support, operations coordination
- Support families experiencing homelessness
- Increase and maintain safe and equitable permanent housing options
- Ensure programs and systems are meeting the needs of people experiencing homelessness
