|                  | <u>Needs Assessment Subcommittee</u> : Delcalzo-Berens provided an overview of the Needs<br>Assessment purpose and goals and invited any interested parties to the next meeting which will<br>follow the January CAB meeting in one week. She also asked for recommended topics for Needs<br>Assessment review.   |
|                  | Wilson reported that his Medicaid lapsed for one month so he lost coverage for January. While his insurance will be restored in February, he lost access to Logisticare and medications making it difficult to maintain his current treatment plan.   |



|               | Roman reported that he sees a greater need for transitional housing for people with HIV. The   |

|               | committee discussed this topic for several minutes. New resources were identified including the  |
|               | HIV/STD hotline which is now placing homeless people living with HIV in shelter or housing within  |
|               | two hours of their call and Project Nest which provides two years of transitional housing in a structured environment with the goal of obtaining permanent housing by program exit. Ferrigno |
|               | reported that there will also be a new women's home for victims of childhood trauma or intimate  |
|               | partner violence. Barriers were identified such as lack of documentation, a lack of willingness of   |
|               | the consumers to relocate, restriction on age to youth, restriction on population type such as   |
|               | MSM (men who have sex with men) only or restriction on gender (men's vs. women's services).  |

|               | Benton reported that she recently had an issue where she was hospitalized and then released to a   |
|               | nursing home for a lengthy period, during which time her housing and other areas of her life   |
|               | became unstable. She identified transitioning to life after nursing or hospice care to be a barrier  |
|               | that should be reviewed.   |
