July 21st Meeting Approval: Delcalzo-Berens

Leadership Committee: Delcalzo-Berens and Martins

Website:

• Delcalzo-Berens shared the updated MSW webpage, currently a work in progress. Delcalzo-Berens welcomed suggestions and feedback from the group participants. D'Egidio would like to include agency's monthly calendars and events. Ruge suggested including a community page for certain and prospect consumers to view for nearby providers, services provided, HIV+ care and treatment information.

Bylaws:

• Delcalzo-Berens introduces a conversation to review and amend the certain MSW Advisory Board bylaws. Discussion was had regarding keeping it a tri-county community or restricting it to Morris County only due to lack of involvement from Sussex and Warren County. If the committee remains a tri-county committee Delcalzo-Berens suggested engaging again with Sussex and Warren providers to determine if their interested in actively participating. Delcalzo-Berens is currently seeking volunteers to assist on this project and outreach.

Needs Assessment:

- Martins, presented an update with the mini-needs assessment regarding telehealth and sexual health activity
 during COVID. Guaman, announced that NEMA will be conducting a similar telehealth survey and will meet on
 11/15/20 to finalize the questions asked. Martins stated that the drafted questions looked similar to those
 that were created by the HIV+ Sub-Committee but did not address sexual activity and exposure to STI and
 HIV. Ruge echoed comments made by Martins and agreed, stating that since the start of the pandemic he has
 noticed an increase in STI and HIV patients seen at Zufall.
- Guaman, encouraged any group participants to join the next meeting on 11/15/20 to advocate for sexual health questions.
- Summer Brown, announced that she already participates on this committee and will draft specific questions to present for the meeting.
- The HIV+ Sub-Committee will meet on 10/27 at 11:00 AM via Zoom to finalize the mini assessment and brainstorm best approach for Brown to present these questions on 11/15.
- Ruge volunteered to chair the Needs Assessment for 2021.

Nominations:

Kelly is nominated for vice chair, Allison is nominated for chair of 2021. Other people can nominate
themselves if they so desire. Opportunity to learn and give leadership experience and do needs assessment
for 2021.

Meeting Calendar:

- Delcalzo-Berens went over 2021 meeting dates. All meetings will continue being presented virtually via Zoom.
- Discussion was had regarding continue providing lunch and learns. Due to the nature of social distancing Ruge and Martins discussed the possibility of hosting small in-person gatherings of clients/consumers (no more than 6) and provide individual lunches. Providing an online component to those who do not feel comfortable would continue being an option.
- The presence of food changes social distancing measures. Delcalzo-Berens advised to table the discussion of lunch and learns until our next meeting to determine the state of the pandemic.

Community Action Board: Delcalzo-Berens

Walker, Martins and Delcalzo-Berens presented a new initiative to engage consumers to participate in CAB.
 Delcalzo-Berens presented a concept of hosting virtual cohorts of no more than 6 people per group. Potential
 for in-person meetings with social distancing and mask requirements. Once the consumers complete the 12 week curriculum each consumer will receive a certification of completion. Walker and Delcalzo-Berens
 encourage any member or group participants to reach out if they have any further suggestions.

- Walker stated that Zufall has received a grant to conduct flu vaccine clinics. In addition, the clinic has added additional pop-sites in their mobile van to conduct COVID, flu and HIV+ testing.
- D'Egidio, shared that their support groups have been seeing good attendance and are going very well. She shared that World AIDS day in works and will reach out with more information.
- Gomez stated that on 11/1/2020 from 2pm to 4 pm EDGE NJ will be hosting youth drop in hours for youth aged 14 to 24.
- Guaman shared that NEMA in the progress on their needs assessment and encouraged everyone to reach out
