Funding Specifications: The primary purpose of Grant-In-Aid General Human Services funding is to provide support for individuals and families facing economic deprivation, family management and/or housing crisis.

All applicants for services must meet the following criteria:

- Be appropriately licensed and maintain the highest standards of quality care.
- Use service outcome measures and performance standards, as required.
- Demonstrate an ability to provide and/or refer individuals to a full continuum of care.

The primary target populations for this funding are: Homeless, working poor, at-risk children aged (0 to 12), families and individuals.

Funding priorities have been identified through the following:

- Morris County Human Services Planning Documents including:
 - Strategic planning and shared efforts with the Continuum of Care (CoC) to reduce homelessness
 - Consolidated Action Plans from the Morris County Office of Community Development
 - HIV Consumer Consortium Reports
 - o HSAC Needs Assessments mandated by NJ Department of Children & Families (DCF)
 - o Program monitoring, quarterly reports and ongoing requests for services.
 - o United Way's Asset Limited Income Constrained and Employed (ALICE) reports
- Based on this information, the Department of Human Services is looking to purchase the following services:
 - Support services for individuals and families at-risk of homelessness, including the following:
 - Emergency shelter
 - Information and referral
 - Case management
 - Transitional housing
 - Housing assistance
 - Services to promote self-sufficiency in individuals and families, including the following:
 - o Training/education
 - o Childcare
 - Transportation
 - Employment-related costs

- Child Care Services, including Support Services for parents and parent education programs.
 - Before/After School
 - Summer Camp
- Developmental and Social Adjustment Services for at-risk youth, including:
 - Case Management
 - Housing Assistance
- Domestic and Child Abuse Services, including the following:
 - o Early intervention to prevent child abuse
 - o Crisis intervention
 - o Information and referral
 - o Shelter
 - Case management
- HIV/AIDS Services, including the following:
 - Housing services
 - Case management
 - Support Groups
 - Education

All 2023 applications will be reviewed by the Morris County Human Services Advisory Council. This review will determine 2023 Grant-In-Aid funding recommendations. County Grant-In-Aid will be awarded based upon availability of funds for calendar year 2023. Should the County receive notification of a reduction in State or Federal funds, 2023 funding may be reduced or terminated. Morris County will not be responsible for replacing or maintaining funding levels in the event that any possible reductions occur in the 2023 allocation process.

The County of Morris reserves the right to renew Subgrant agreements for the period of January 1, 2024 through December 31, 2024, based upon annual program review and the availability of funding.
