IV. Presentation on Code Blue – Ms. Fodali, Morris County Office of Temporary Assistance (OTA), Ms. Kam Freitas, Homeless Solutions, and Mr. Wes Gaynor, Homeless Solutions

Ms. Fodali gave a PowerPoint presentation on Code Blue; see attached.

- Questions/Comments
 - Mr. Johnson, thank you for that information; there was a lot of good data. Given that the past two winters have been relatively mild, what are you contributing to the increases in Code Blue Nights? Ms. Fodali stated that there's a variety of factors that contribute to the increase in bed nights. The number of households served and the number of services provided. One of these factors is accessibility to services, and in general, there is more of a coordinated effort to provide services and get them to those in need. Ms. Bjornson added that those seeking shelter are more accepting, understanding, and given more information than in the past. Fear of staying in a shelter has changed their perspective since they can access meals, showers, and additional services.
 - Ms. Errico commented that this was a great presentation and an important one to have. Showcasing the collaborative effort that goes into the work in Morris County to address the significant challenges in the community.

 - Thank you to those members that attended HOME ARP Allocation Plan Stakeholders meetings. HUD has accepted the Morris County HOME ARP Allocation Plan. We will meet with our consultants in April to finalize our timeline. More information to follow.
