VI. Staff Reports

Human Services - Ms. Archer

Our Human Services 2023 Funding Cycle will begin soon. We encourage everyone to check the county website at https://www.morriscountynj.gov/Departments/Human-Services-Human-Services-Boards-Committees/Human-Services-Advisory-Council for the Request For Application (RFA) and the Daily Record for the announcement.

We fund the Warming Center at Homeless Solutions through the HSAC Grant-In-Aid (GIA) 2022 funding. The Warming Center could not open this year due to renovations and other events beyond its control. We are choosing to fund an Overnight Center, an excellent opportunity for the county. Ms. Fodali will discuss some details and OTA's involvement with the program. Ms. Fodali stated that the Overnight Center is an emergency shelter model piloting for Spring 2022. The center opened on May 2nd and will stay open through September 5th. There are 14 beds available for single individuals. There are movable dividers, locker storage space, laundry facilities, showers, and hot meals, snacks, and beverages are also offered to guests. Referrals are made through OTA during work hours Monday through Friday, and then NJ-211 will make the referrals after hours, on weekends, and holidays.

Thank you to those that participated in the HOME ARP Stakeholder Meeting. There was a great turnout, and a wealth of knowledge and information was gathered. A Gap in Services Analysis will be provided soon.

Community Development Annual Action Plan is posted on the County website at https://www.morriscountynj.gov/Departments/Community-Development. The public hearing was held last night, and there was no public comment on the Action Plan. The community received feedback as they were pleased with what is currently being funded through Community Development.

Council on Aging, Disabilities & Veterans – Ms. Hellyer

- AGING
 - The office is closing the yearly needs assessment survey, and the results will be out in June
 - The office is holding a public meeting to discuss services to provide insight for the 2023 grant year
 - May was Older American Month, and this year's theme is "Age My Way."
 - The Nutrition Program offers various socialization events at the Congregate sites, serving 150 clients. These events include bird house decorating, chair Zumba and painting kits.

MAPS

- On April 11, 2022, MAPS Paratransit began offering new trip purposes for registered riders
 - Transportation for the following trip purposes can be booked from 10 am 4:30 pm depending on availability
 - Grocery Shopping (shopping policy must be followed)
 - Pharmacy
 - Bank
 - Personal Care: such as hairdressers/barber
 - This is a shared-ride service that will piggyback off our pilot Lyft Program with mobile individuals who have a cell phone with text ability.
 - MAPS will provide transportation to non-ambulatory individuals when needed.
 - Regardless of trip purpose, MAPS vehicles do not wait for individuals at the destination.
 - Return trips must be booked a minimum of thirty minutes after initial drop-off.

Workforce Development Board - Ms. Armstrong

We are nearing the end of our fiscal year. Our fiscal year starts July 1st and ends June 30th. At the end of the year, we are looking at budget expenditures and preparing a budget for approval for the following year. We have expended nearly 60% of our funding, which is good news since that didn't happen the prior year.

During COVID, we saw a decrease in outreach for those interested in training since the work requirement was waived. Our youth programs also saw a decline of 20%. Our youth programs serve out-of-school youth primarily, and many do not have access to the internet or computers. Since our programs are designed to be in-person, our providers scrambled to either find equipment or provide equipment for those clients needing education programs, high school equivalency programs, and the high school equivalency test migrate to an online testing system.

The Warren County Community College is an HSC Testing site and has been closed for the past two years and has reopened as of April.

• Ms. Csengeto asked, "is the Randolph location open for those not on welfare to go and look for a job?" Ms. Armstrong stated yes, the site is open by appointment only. They can call 862.397.5600 or go to https://www.nj.gov/labor/ to schedule an appointment.

IX. Subcommittee Report

Child Care Update – Ms. Sherrod, Chair

- State of Child Care in Morris County
 - o 22 Childcare Centers permanently closed since March 2020
 - o Total number of Registered FCC Providers for March is 34
- NJ DHS DFD Initiatives
 - O Continuing to help eligible families by covering the additional amount they may owe for fees or the difference between what the state pays and the provider charges. This assistance began in September and is now extended to December 2023. These additional payments provide up to \$300 for full-time care, or \$150 for part-time care, per eligible child, per month on top of the childcare assistance rate paid by the state on behalf of the family.
 - O Waiving co-payments in the state's childcare subsidy
 - o Summer Camp grants will be available on May 9th (summer camps do not have to receive childcare assistance funding to be eligible for these grants)
 - o Grants for capital improvement will be available in Fall 2022

- Childcare Centers can apply for up to \$150,000 to make improvements in the center, i.e., bathrooms, sinks, remodeling
- Child & Family Resources is partnering with United Way in their efforts for their project, United in Care.

Planning Update – Mr. Bashe, Chair

The committee met last week. There was a discussion about mental health, grief, and the Human Services delivery system. People are experiencing more depression, anxiety, anger, and frustration, so a task force will be formed to identify some of the common issues and how we can provide our agency staff members coping mechanisms and education on de-escalating an upset client.

Legislative Update – Ms. O'Reilly-Stanzilis

- Homeless Trust Fund
 - There have been a series of events and frustration trying to get this in front of our County Commissioners. 12 Counties in New Jersey have an active Homeless Trust Fund and a Homeless Trust Fund Task Force. Monarch Housing has put together a 26-page White Paper with an Executive Summary, which includes the needs and gaps and the purposes of a Homeless Trust Fund. It identifies who is homeless in Morris County and the value and history of the fund. This conversation is to breathe new energy into this initiative so that an appointed committee to formally bring this issue back to the County Commissioners for consideration of review.
 - O Six months ago, a letter was sent from HSAC to the County Commissioners to support the Homeless Trust Fund. To date, a formal response to that letter has not been received. We are looking to restart an effort to open a conversation with the Commissioners and possibly get this topic on the next meeting agenda. Discussion ensued.

X. Advisory Committee Reports

Morris, Sussex, and Warren HIV Advisory - Mr. Armstrong

- The Morris, Sussex, Warren HIV Advisory Committee and the Early Intervention and Retention Collaborative (EIRC) met online on May 23, 2022. These two organizations meet as an HIV consortium. The Commissioners of Morris County created the MSW HIV Advisory Committee. The EIRC is created by HRSA's Ryan White Part A program. They have not met since the last HSAC meeting.
- The HIV Consortium began a series on the best practices with the exploration of at-risk communities for HIV/AIDS.
- Mr. Nicholas Leeper, EDGE NJ, presented on LGBTQ+ Cultural Humility.
 - o Policy and Understanding LGBTQ+ Statistics
 - o Apply the theory of intersectionality regarding the LGBTQ+ Community
 - o Understand Privilege and Societal Norms
 - o Gain Insight into Stigma
- The Lived Experience Project has just graduated the first cohort of HIV+ people who access HIV services in Morris County. The educational curriculum received positive feedback, and there are plans to continue

- Mr. Armstrong, an HSAC member, will speak about these experiences living with AIDS, the psycho-social context of HIV/AIDS, the End the HIV Epidemic initiative, and provide HIV resources in an online forum of the North Jersey Health Collaborative (NJHC) on June 22nd at 11:00 am-noon. The NJHC Forum is free, and registration is needed.
- The next meeting is Monday, July 25th at 1:00 pm.

Mental Health Addiction Services Advisory Board - Ms. Csengeto

- NJ DMHAS announced a presentation for Partial Care Providers on Wednesday, June 8, 2022, from 1:00 pm 3:00 pm. This session is designed to provide stakeholders, specifically Medicaid partial care providers, a better understanding of best practices to prevent, avoid and detect fraud, waste, and abuse in the Medicaid program.
