Section 1. The Authority hereby appoints the following persons to the following respective offices of the Authority:

- e. Assistant Secretary: Scott Gallopo

Section 2. Such officers are hereby severally authorized and directed to discharge the rights, duties and obligations of their respective offices to the extent provided for under applicable law, including the Act and in accordance with the provisions of the by-laws of the Authority adopted by resolution no. 02-13 on August 14, 2002, and entitled, "RESOLUTION ADOPTING THE BY-LAWS OF THE MORRIS COUNTY IMPROVEMENT AUTHORITY", as amended by resolution no. 04-18 on June 9, 2004, and entitled, "RESOLUTION AMENDING THE BY-LAWS OF THE MORRIS COUNTY IMPROVEMENT AUTHORITY", as amended by

resolution no. 05-21 on October 11, 2005, and entitled, "RESOLUTION AMENDING THE BY-LAWS OF THE MORRIS COUNTY IMPROVEMENT AUTHORITY", from the date of adoption of this resolution at the Authority's 2020 annual meeting through the Authority's 2021 annual meeting to be held in February, 2021.

Section 3. Subject to the second sentence of this section, this resolution shall take effect immediately.
