MINUTES of the Regular Board Meeting held on January 18, 2017 at 6:00 p.m. Conference Room #547 Administration and Records Building, Morristown, New Jersey

At 6:00 p.m., John Bonanni, Chairman to the Morris County Improvement Authority called the meeting to order. The following persons were in attendance:
