- 3. Executive Session Move to enter into Executive Session occurred at 5:14 p.m. Commissioner Sandman made a motion to enter into Executive Session to discuss the Courthouse Expansion and Solar I maintenance. Commissioner Gallopo seconded the motion.

Agenda item 5(i) was discussed - Resolution authorizing the issuance of refunding bonds for Morris Solar II. Commissioner Sandman made a motion to adopt this resolution. Commissioner Gallopo seconded the motion. Roll was called. The resolution was unanimously approved.
