- 1. Commissioner Bonanni, Chairperson, asked for the reading of the public statement in accordance with the Open Public Meetings Act, which was then read by Christine Kristiansen, Recording Secretary.
- 2. Commissioner Bonanni asked for "roll call" for the Authority. Five (5) Commissioners were in attendance, Mr. John Bonanni, Ms. Beti Bauer, Mr. Scott Gallopo, Ms. Christine Ramirez and Ms. Ellen Sandman. A quorum was established.
- 3. Executive Session No Executive Session requested.
- 4. Commissioner Bonanni asked for approval of the September 16, 2020 meeting minutes. Commissioner Ramirez made a motion to accept the minutes of the September 16, 2020 meeting. Commissioner Gallopo seconded the motion. All others were in favor to accept the minutes of the September 16, 2020.

Discussion: Solar I Operations and Maintenance:

- Stephen Schneider of Sunlight General Capital summarized the findings of their site inspections and testing of the Solar I systems, and discussed their recommendations to the Board for maintaining and repairing the Solar I sites and equipment.
- Andrew Conte of Gabel Associates discussed the Solar I system designs; the importance of addressing the maintenance items and continuing intensive preventative maintenance; and provided the Board with recommendations.

Agenda item 5(i) was discussed – Resolution consenting Azimuth 180 Solar Electric LLC to undertake various capital improvements in connection to Solar I. Commissioner Gallopo made a motion to adopt this resolution. Commissioner Ramirez seconded the motion. Roll was called. The resolution was unanimously approved. "RESOLUTION OF THE MORRIS COUNTY IMPROVEMENT AUTHORITY CONSENTING TO THE UNDERTAKING BY AZIMUTH 180 SOLAR ELECTRIC, LLC OF VARIOUS CAPITAL IMPROVEMENTS IN CONNECTION WITH THE AUTHORITY'S RENEWABLE ENERGY PROGRAM, TRANCHE I" (No. 20-28) was adopted.

Agenda item 5(ii) was discussed - Resolution authorizing an amendment to the 2020 Authority Budget. Commissioner Gallopo made a motion to adopt this resolution. Commissioner Ramirez seconded the motion. Roll was called. The resolution was unanimously approved. "RESOLUTION AUTHORIZING AN AMENDMENT TO THE 2020 AUTHORITY BUDGET FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2020 AND ENDING DECEMBER 31, 2020" (No. 20-29) was adopted.

Agenda item 5(iii) was discussed. Resolution introducing and approving the 2021 Authority budget. Commissioner Bauer made a motion to adopt this resolution. Commissioner Gallopo seconded the motion. Roll was called. The resolution was unanimously approved. "RESOLUTION INTRODUCING AND APPROVING THE 2021 AUTHORITY BUDGET FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2021 AND ENDING DECEMBER 31, 2021" (No. 20-30) was adopted.

Agenda item 5(iv) was discussed. Resolution adopting standards and protocols for holding remote public meetings as required by the Division of Local Government Services. Commissioner Bauer made a motion to adopt this resolution. Commissioner Gallopo seconded the motion. Roll was called. The resolution was unanimously approved. "RESOLUTION OF THE MORRIS COUNTY IMPROVEMENT AUTHORITY ADOPTING STANDARDS AND PROTOCOLS FOR THE CONDUCT OF PUBLIC MEETINGS DURING DECLARED PUBLIC HEALTH OR SIMILAR EMERGENCIES, AND PUBLIC PARTICIPATION THEREIN" (No. 20-31) was adopted.

Agenda item 5(v) - Resolution approving the payment of bills as listed on the Schedule of Warrants in the amount of \$1,616.55 Commissioner Gallopo made a motion to adopt this resolution. Commissioner Ramirez seconded the motion. Roll was called. The resolution was approved unanimously. The motion carried and Resolution "Bill List" (No. 20-32) was adopted.
