RESOLUTION OF THE MORRIS COUNTY IMPROVEMENT AUTHORITY APPROVING AND AUTHORIZING THE EXECUTION OF AN ESCROW AND FUNDING AGREEMENT WITH DM AIRPORTS, LTD. AND MORRISTOWN AIRPORT CUSTOMS ASSOCIATION

WHEREAS, the Morris County Improvement Authority (the "Authority") has been duly created by resolution of the County of Morris (the "County"), State of New Jersey (the "State") and exists in good standing as a public body corporate and politic under and pursuant to all applicable law, including the county improvement authorities law, constituting Chapter 183 of the Pamphlet Laws of 1960 of the State, as amended from time to time (codified at N.J.S.A. 40:37A-44 et seq., the "Act"); and

WHEREAS, DM Airports, Ltd. ("DM") is the lessee, manager and operator of the Morristown Municipal Airport (the "MMA") located in Hanover Township, in the County of Morris, New Jersey; and

WHEREAS, Morristown Airport Customs Association ("Customs Association") currently provides facilities for customs clearance at MMA; and

WHEREAS, DM serves as the administrator of Customs Association; and

WHEREAS, DM and Customs Association are seeking to explore the potential for the issuance of obligations (the "Bonds") by MCIA to provide funding for various capital improvements to MMA, including, but not limited to, the construction of a United States Customs Facility (the "Financing"); and

WHEREAS, the Authority will need to engage third party professionals, including counsel and municipal advisor, in connection with (i) developing the proposed structure of the Financing (the "Preliminary Services") and (ii) the authorization, sale and issuance of the Bonds (the "Bond Services" and, together with the Preliminary Services, the "Services"), and DM, on behalf of Customs Association, has agreed to deposit with the Authority an initial amount of TEN THOUSAND and 00/100 (\$10,000.00) DOLLARS (and, together with all other deposits made hereunder, the "Escrow Amount"), to be deposited in an escrow account and held or disbursed in accordance with the provisions of this Agreement to pay costs incurred by or on behalf of the Authority in connection with the Services; and

- **WHEREAS,** the Authority, DM and Customs Association desire to enter into a Funding Agreement (in the form attached hereto as Exhibit A), and the Funding Agreement has been presented to the Board of Commissioners for review and consideration; and
- **WHEREAS,** the Board of Commissioners, having reviewed the Funding Agreement, authorize the execution of the Funding Agreement and authorize delivery of same to DM and Customs Association.
- **NOW THEREFORE BE IT RESOLVED** by the Board of Commissioners of the Authority as follows:
- **Section 1**. The aforementioned recitals are incorporated herein as though set forth at length.
- **Section 2.** The Chairperson of the Authority (including his designees, each an "Authorized Officer"), is hereby authorized and directed, in consultation with counsel to the Authority, to execute and deliver the Funding Agreement in the form set forth in Exhibit A attached hereto, with such additions, modifications or deletions recommended by counsel to the Authority and agreed by the parties to such Funding Agreement.
- **Section 3**. The Secretary of the Authority is hereby authorized to attest to the execution of the Funding Agreement and affix the Authority seal onto same.
- **Section 4**. Each Authorized Officer of the Authority is hereby authorized to take all action deemed necessary, useful or convenient in connection with the foregoing and in furtherance of the Funding Agreement.
 - **Section 5**. This resolution shall take effect in accordance with applicable law.
