RESOLUTION OF THE MORRIS COUNTY IMPROVEMENT AUTHORITY CONCERNING REVIEW OF FINDINGS AND RECOMMENDATIONS OF THE LOCAL FINANCE BOARD PURSUANT TO N.J.S.A 40A:5A-7.

WHEREAS, the findings and recommendations issued by the Local Finance Board (the "*Board*") at a meeting held by the Board on December 8, 2021 pursuant to N.J.S.A 40A:5A-6, N.J.S.A. 40A:12A-67(g) and N.J.S.A. 40A:12A-29(a)(3) relating to the review of a proposed project financing consisting of the issuance of non-recourse Redevelopment Area Bonds (The District at 1515 Redevelopment Project) pursuant to N.J.S.A. 40A:12A-64 *et seq.*, in an aggregate principal amount not to exceed \$6,450,000 through a negotiated private placement, to finance the costs related to the implementation of a Redevelopment Plan for certain property located in the Township of Parsippany-Troy Hills pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 *et seq.*, have been filed with the Secretary of the Authority, and copies have been received by each member of the governing body, attached hereto as **Exhibit A**; and

WHEREAS, N.J.S.A. 40A:5A-7 requires that the governing body of the Authority shall, within 45 days of receipt of the Board's findings and recommendations, certify by resolution of the Authority that the members thereof have personally reviewed the findings and recommendations; and

WHEREAS, the members of the governing body of the Authority have personally reviewed the Board's findings and recommendations for the Authority as evidenced by the group affidavit of the governing body; and

WHEREAS, failure to comply with this requirement may subject the members of the Authority to the penalty provisions of N.J.S.A. 52:27BB-52.

NOW, THEREFORE, BE IT RESOLVED that the governing body of the Authority hereby states that it has complied with the requirements of N.J.S.A. 40A:5A-7 and does hereby submit a certified copy of this resolution and the required affidavit to the Board to show evidence of said compliance.
