## **Election of Officers**

## ACTIONS RESULTING FROM CLOSED SESSION

No actions were taken.

#### REPORT OF DIRECTOR & ATTORNEY

SADC Annual PIG Application filed with SADC on December 15th. Ms. McCulloch informed the board that she had submitted the annual updates to the PIG Application.

## **RIGHT TO FARM**

*Morris Twp.* – *draft RTF Ordinance* – Ms. Coyle informed the board that the RTF Ordinance was adopted on December 14<sup>th</sup>.

Sipos (Frog Hollow Farm). Ms. Coyle informed the board that on January 12, 2012, the owners of Frog Hollow Farm submitted a packet of information regarding their Right to Farm case involving property they own in Hunterdon County. The farmers own a preserved farm in Morris County and a parcel in Hunterdon County. In their letter, the farm owners asked the Morris CADB to advocate their position at the Agricultural Convention in Atlantic City. Ms. Coyle provided the background information about the case including a review of the Hunterdon CADB and the Office of Administrative Law decision. Ms. Coyle further informed the board that since the Convention took place prior to the CADB's meeting, she responded to the farm owners' request stating that Morris CADB cannot advocate for a farmer involved in a RTF matter. The CADB is required by law to hear RTF cases and render decisions. The CADB is an impartial body akin to a judge in a court of law. Should a RTF case be filed against the farm in Morris County, the CADB would be charged with determining whether their farm meets the eligibility criteria of the RTF Act and whether the activity in question constitutes a generally accepted agricultural management practice. The CADB cannot make an advisory without a formal review as outlined in the RTF regulations.

## **CORRESPONDENCE**

The board reviewed two newspaper articles regarding the sales of Scott Farm 1 and 2 in Washington Township.

## **OLD BUSINESS**

Ms. Coyle and Ms. McCulloch informed the board that Chairman Keller, Ms. Cybulski, Mr. Chang and CADB staff met with Freeholders Nordstrom and Grossi regarding the proposed changes to the preservation program.

## **NEW BUSINESS**

Proposed amendment to Policy: P-8: Ranking System. Ms. Coyle presented to the board a draft revision of the policy. If approved, the policy would state that "if an application fails to meet the criteria listed in Paragraph 1, the Morris CADB reserves the right to waive the minimum criteria and to accept and consider the application on a case-by-case basis." The board discussed the revision and agreed to consider adopting the revised policy if the Freeholder Board agrees to the proposed preservation program changes.

*Davis/Shaffer Farm, Chester Twp. – termination of 8-Year Program.* Ms. Coyle informed the board that the Davis/Shaffer Farm 8-Year Program had expired and that the farm owners do not wish to renew the program in light of the fact that the farm is now permanently preserved. On motion of member Wightman, seconded by member Ort, the board approved the "Notice of Termination of Municipally Approved Farmland Preservation Program". A roll call vote was taken.

Oakes Farm, Rockaway Twp. - revised farm proposal. Ms. Coyle informed the board that the owners of the Oakes Farm submitted a revised plan for the construction of several agricultural structures including a pole barn, a mare barn, and an indoor riding arena. The board reviewed the plans and agreed that the plan was in compliance with the Deed of Easement. On motion of member Wightman, seconded by member Ashley Myers, the board directed staff to inform the farm owners in writing of the board's decision. A roll call vote was taken.
