## **RIGHT TO FARM #1**

L. Simone, Gooserock Farm – Request for SSAMP. Ms. Coyle informed the board that Ms. Landi Simone, owner of an apiary called Gooserock Farm, submitted an application for a SSAMP for her operation. Mr. Bush informed the board that the CADB has a conflict of interest in this matter (an adjoining property owner is Freeholder Deputy Director Douglas Cabana; Freeholder Cabana has expressed a grievance against the operation) and, therefore, cannot proceed with the application. On motion of member Wightman, seconded by member Ashley Myers, the board directed staff to contact the SADC and request their assistance with finding another CADB to hear the application and to notify the farm owner about the conflict of interest and the application process. # **RIGHT TO FARM #2**

Alex Adams, Denville Twp. - Mr. Bush and Ms. Coyle informed the board that on April 23, 2012, Honorable Judge Minkowitz ordered that the Summons Complaint by Denville Township v. Alex Adams shall be held in abeyance pending a determination by the Morris CADB and the SADC as to whether Mr. Adams' property or properties constitute a commercial farm subject to the protections of the Right to Farm Act. If the agencies determine that the properties qualify as a commercial farm under the RTF Act, then the Municipal and Superior Court lack subject matter jurisdiction in the matter and the Summons Complaint shall be dismissed. If the properties do not constitute a commercial farm, then the matter shall be heard by the Superior Court. Staff further stated that they would inform the municipal attorney regarding the conflict resolution procedures under the RTF Act so that the municipality could file an official complaint with the CADB and the conflict resolution process may be initiated.
