*Matthew Johnston, Washington Twp. – Request for SSAMP #1.* Ms. Coyle informed the Board that she had distributed Resolution 2014-06, which was adopted at the May meeting.

Matthew Johnston, Washington Twp. – request for SSAMP #2. Ms. Coyle presented a draft SSAMP Review Checklist for the Board's review and consideration. On motion of member L. Anthony Cappuccio, Washington Twp. – Complaint. Ms. Coyle informed the Board that the SADC was in the process of reviewing the farmer's Commercial Farm Certification and that the SADC conducted a site visit on May 1, 2014.

*Fish Farm, Florham Park – Complaint.* Ms. Coyle presented to the Board a Staff Report regarding eligibility for Right to Farm Act protections. The Board discussed the report and made the following determination:

- the Fish Farm is a "commercial farm" as defined by the Right to Farm Act;
- the dispute involves activities related to the production of livestock (beef); production of livestock is included on the list of permitted activities set forth in N.J.S.A. 4:1C-9;
- cows getting out of the Fish Farm property pose a direct threat to the health and safety of the residents and drivers in Florham Park; and
- the Fish Farm does not meet the eligibility criteria pursuant to N.J.S.A. 4:1C-9, and is therefore ineligible for the protections of the Right to Farm Act.
