RIGHT TO FARM #2

Anthony Cappuccio, Washington Twp. – Complaint. Ms. Coyle informed the Board that Washington Township had withdrawn their complaint.

Fish Farm, Florham Park – Complaint. Ms. Coyle informed the Board that she had distributed Resolution 2014-12, which was adopted by the Board at the June meeting. Mr. Bush advised the Board that the CADB's decision had been appealed by the farm owners. The appeal was transmitted by the SADC to the OAL.

William Benkendorf, Washington Twp. – Complaint. Ms. Coyle informed the Board that Ms. Barbara Margolese, Washington Township Zoning Officer, had filed a complaint against Mr. Benkendorf's operation on the Snowbird Farm in Washington Township. On motion of member Wightman, seconded by member D. Davis, the Board directed staff to forward a copy of the complaint to Mr. Benkendorf and to request a Commercial Farm Certification. A roll call vote was taken.

Valley Shepherd, Washington Twp. – Complaint. Ms. Coyle informed the Board that in a July 8, 2014 letter to Municipal Judge Frank Leanza, Anthony Sposaro, Esq., the farmer's attorney, challenged the CADB's February 19, 2014 decision that in light of the Notices of Violation issued by the NJDEP and the NJDA against Valley Shepherd Creamery, the CADB could not grant a hearing. Ms. Coyle then presented to the Board her July 9, 2014 memorandum in response to Mr. Sposaro's letter. Ms. Coyle stated that Mr. Sposaro's remedy was to appeal the CADB's decision to the SADC. Pursuant to N.J.A.C. 2:76-2.7(k), "Any person aggrieved by the decision of the board regarding a complaint against a commercial farm in accordance with this section shall appeal the decision to the Committee within 10 days from receipt of the board's decision. The Committee shall schedule a hearing and make a determination within 90 days of receipt of the petition for review.

- 1. The decision of the Committee shall be binding, subject to the right of appeal to the Appellate Division of the Superior Court.
- 2. Any decision of the board that is not appealed shall be binding."

Ms. Coyle informed the Board that Mr. Sposaro never appealed the CADB's decision.

Vincent Carrabba, Mendham Twp. – complaint. Mr. Bush informed the Board that he had spoken with Mr. Carrabba's attorney, Scott Carson, Esq., who had submitted a written request to table the matter until the next CADB meeting to allow for the submittal of a formal written position. The Board agreed to table the matter until the August meeting.
