## COMPLIANCE WITH THE OPEN PUBLIC MEETINGS LAW

# APPROVAL OF MINUTES

On motion of member L. Davis, seconded by member Wightman, the Board approved the minutes of the September 11, 2014 regular meeting. A roll call vote was taken.

### OPEN TO THE PUBLIC FOR NON-AGENDA ITEMS

Mr. Kurt Maier informed the Board about Washington Township Municipal Utilities Authority's (WTMUA) Parker Road project.

The Board discussed the fact that two preserved farms are impacted by this project, Maier and Killion. Mr. Maier stated that the owners of the Killion farm had applied for an agricultural exemption, but were denied because they currently only have three horses. The MUA will require that their existing well be capped and the entire farm hooked up to the public water system. The Board expressed concern about the fact that the farm is preserved in perpetuity and must have continued access to the existing onsite well for current and future agricultural uses. Even though it is not intensely farmed currently, the use could change in the future and require significant amounts of untreated water. In addition, Mr. Maier stated that he was informed that that he may be required to conduct annual well water testing to check for contamination. He has 5 wells and the cost of testing would be several thousand dollars annually. Ms. Coyle stated that she would reach out to the MUA to gather information and to request the MUA to consider the CADB's concerns.

Mr. Maier left at 7:50 p.m.

#### **RIGHT TO FARM**

William Benkendorf, Washington Township. – Complaint.

Ms. Coyle presented the Staff Report, which was marked as Exhibit B-8 for the purposes of drafting the final resolution.

Mr. Bush swore in Mr. William Benkendorf. Mr. Benkendorf presented his case to the Board.

The Board reviewed Mr. Benkendorf's Commercial Farm Certification and reviewed the eligibility criteria of the RTF Act, including the history of state law violations related to Mr. Benkendorf's operation.

On motion of member Wightman, seconded by L. Davis, the Board voted that Mr. Benkendorf's operation is not a "commercial farm" as defined by the RTFA and does not meet the eligibility criteria of the RTFA. The Board dismissed the complaint. Staff was directed to draft a resolution memorializing the Board's decision. A roll call vote was taken.
