The Board agreed that the application does not meet the Deed of Easement requirement that "the division shall be for an agricultural purpose."

## **REPORT OF DIRECTOR & ATTORNEY**

*Monitoring: Western Region*. Ms. Coyle informed the Board that monitoring inspections of Western Region farms began on October 22, 2014 and that Planning staff has been assisting with the field work.

Washington Township Municipal Utilities Authority: Parker Road project. Ms. Coyle informed the Board that the WTMUA will permit the owners of the Maier and Killion farms to keep their wells for the agricultural operations. The owners will not be required to conduct annual testing. The WTMUA will be notifying the farm owners in writing and will copy the CADB and the SADC on the correspondence.

Centenary College – cell tower. Ms. Coyle informed the Board that she had sent correspondence to Centenary College and to Washington Township regarding deed restrictions and the application process for a wireless facility on preserved farmland.
