#### REPORT OF DIRECTOR & ATTORNEY

*Open Space Liaison.* Ms. Coyle informed the Board that member Keller's term would be expiring at the end of the year and that the Board needed to appoint a new liaison. The Board discussed the appointment. Member Keller agreed to serve another term.

Annual Planning Incentive Grant Application. Ms. Coyle informed the Board that as part of the process of preparing the annual PIG application, she had sent a notification letter to each municipality that has farms that are targeted for preservation. No comments have been received.

Monitoring – Western Region. Ms. Coyle informed the Board that monitoring of Western Region farms was underway. Monitoring of farms in Chester Township and Borough will be concluded by the end of October. Farms in Washington and Mt. Olive Townships will be monitored during the months of November and December.

Legislative Updates. Legislative updates were shared with the Board via email prior to the meeting.

#### CORRESPONDENCE

*John Crater Farms, Washington Twp.* – *request for SADC enrollment.* The Board reviewed the landowner's request. On motion of member Ashley Myers, seconded by member Wightman, the Board authorized staff to begin the process of enrolling the farm in the state program provided that there will be no cost to the County associated with the enrollment. If there is a cost

associated with the process, the Board will review the cost before proceeding with the enrollment.

<u>PUBLIC HEARING</u>: Modification of Agricultural Development Area to include Black 42, Lot 33 in the Township of Chester.

Ms. Coyle stated for the record that a "Legal Notice of Public Hearing" was published on September 24, 2015 pursuant to N.J.A.C. 2:76-1 et seq.

Ms. Coyle stated that the ADA identifies "...lands that are currently in agricultural production or have a strong potential for production and in which agriculture is permitted under the current municipal zoning ordinance..." Ms. Coyle explained the need for inclusion of the above listed lots in the ADA - to be eligible for a farmland preservation cost-share grant from the SADC, a farm must be part of the county's ADA. Black 42, Lot 33 in Chester Township is part of a pending application for permanent preservation.

Ms. Coyle stated that no comments (written or verbal) had been submitted prior to the Public Hearing. No comments (written or verbal) were submitted during the Public Hearing.

On motion of member Wightman, seconded by member D. Davis, the Board adopted Resolution 2015-12, Modification of Agricultural Development Area to include Black 42, Lot 33 in the Township of Chester. A roll call vote was taken.
