M. Picozzi, Harding Township – enforcement of Deed of Easement. Mark Roselli, Esq., attorney for Harding Township, introduced himself and provided the case history. He also shared with the Board photographs taken of the Picozzi barn in October 2016 by Mr. George Byrnes, Harding Township Zoning Officer. The photographs clearly show hockey rink boards with plexi-glass, batting cage, hockey goal, hockey sticks and pucks, as well as an artificial skating surface. Mr. Roselli stated that the construction of the barn was approved by the municipality based on Mr. Picozzi's representation that it would be used strictly for agricultural purposes. Based on this representation, the barn was approved for a height of up to 35 feet. A structure utilized for non-agricultural purposes cannot exceed 25 feet. Mr. Roselli further stated that the barn's height exceeds 25 and also confirmed that hockey rinks are not permitted in the zone. The Board thanked Mr. Roselli for attending the meeting. Mr. Roselli departed at 7:55 p.m.
