Mr. Pinto, on behalf of the farm owners, Mary and Donald Alldian, presented the application. Mr. and Mrs. Alldian wish to construct a solar energy generation facility on their preserved farm. The facility will provide power to the residential facility located on the non-severable exception area and any future agricultural structures built on the farm. The facility will directly reduce the farm's electric costs.

Ms. Coyle reviewed the eligibility criteria outlined in the regulations, discussed the information provided by the applicants and concluded that the application is complete pursuant to N.J.A.C. 2:76-24.5. Ms. Coyle further stated that the application meets the requirements of N.J.A.C. 2:76-24.1 et seq. and that staff recommends approval of the application.

On motion of member Ashley Myers, seconded by member Ort, the Board approved the application for the construction of a solar energy generation facility on the Alldian preserved farm. A roll call vote was taken.
