Vice Chairman Engelbart stated that adequate notice of this meeting in compliance with the Open Public Meetings Act has been provided and filed with the Morris County Clerk, the Daily Record and the Star Ledger.

#### **PUBLIC COMMENTS**

There were no comments from the public.

### **BOARD MEMBER APPRECIATION**

Freeholder Deputy Director Shaw thanked four Board members for their services on the HP Board: Eileen Stokes (Region I, 6 years), Nita Galate (Region II, 6 years), Monica Scozzafava (Region III, 6 years), and Larry Fast (Morris County Heritage Commission, 16 years). They each received a special resolution of honor issued by the Board of Chosen Freeholders.

During his tenure, member Fast evaluated more than \$53.2 million in grant requests and recommended more than \$36.1 million in grant funding for various historic preservation projects and served as Chairman of the Board from 2008 to 2011. Members Stokes, Scozzafava and

Galate, who has chaired the board since 2019, evaluated more than \$23.6 million in grant requests during their tenure and recommended more than \$18.6 million in grant funding for various historic preservation projects.

### **RESULT OF E-MAIL VOTE**

2016 Hartley Dodge Memorial Grant Extension

The Borough of Madison requested a grant extension for its 2016 Hartley Dodge Memorial grant (unspent funds include bidding and construction administration for the Plaza Restoration project) even though the Borough is technically out of extensions (Second extension expired March 27, 2020). The County's special counsel has advised that if the HP Board wants to grant an additional extension due to COVID, it could make such a recommendation to the Freeholders. As the Borough anticipated the construction period to be 28 weeks, the extension could be for 18 months (to cover the period from the expiration of the second extension) or expiring September 27, 2021. Through e-mail vote received by October 14, 2020, the HP Board recommended the Freeholders to grant an 18-month final extension due to the COVID pandemic to the 2016 grant for the Hartley Dodge Memorial with an expiration date of September 27, 2021.

# **GRANT PROJECT UPDATE**

Mr. Chang used a PowerPoint to present a grant project update to the Board: Since November 2019, grantees have completed 4 Preservation Plans / Condition Assessments with grant amount of \$83,428; 8 Construction Documents with grant amount of \$207,131; and 14 Construction Projects with grant amount of \$1,777,497.
