# **PROPOSED RULES ON TERMINATION OF EASEMENT**

Mr. Chang advised that the draft rules apply to the entire HP program, and are not specific to any particular grant project. However, if adopted by the Freeholders, they would be applicable to Harding Township, which is applying to Green Acres for disposal of a portion of the Glen Alpin property (including the mansion). The Board reviewed the draft rules and the comments/ feedback regarding these rules from NJ Historic Preservation Office.

Regarding the proposed requirement #10 (of 12 requirements), the Board agreed that it could work with the applicant and staff to arrive at a "reasonable compensation" to be recommended to

the Morris County Board of Chosen Freeholders. Mr. Napolitano advised that the NJ DEP is looking to the County for a model of regulations relating to the termination of historic preservation easement, and that these rules can be refined as time goes on.

Mr. Chang advised that requirement #8 would be revised with the addition of the citation for the New Jersey Register of Historic Places Act.

On motion by member Engelbart, seconded by member Stokes, the Board voted to recommend to the Morris County Board of Chosen Freeholders the adoption of the proposed rules on the Termination of Easement on Preserved Historic Properties with the revision on requirement #8.
