Hartley Dodge Memorial, Madison – 2017 Grant

TERMINATION OF HP EASEMENT

Glen Alpin, Harding (2005 ~ 2007 Grants)

Mr. Chang advised the Board that, as required by HP rules (Sec. 5.17-C3), the Township of Harding held a public hearing on April 19, 2021 to receive public comments on its request to terminate the HP easement on the Glen Alpin property. A summary of the comments received at the public hearing and the Township's responses were provided to the Board.

The Board will hold a special meeting on Wednesday, May 19, 2021 at 7:00 P.M. to hear Harding Township's presentation regarding its request to terminate the HP easement on Glen Alpin and its plan for compensation. The Township has posted information on its website under Quick Links "Glen Alpin Disposal/Diversion Application - Green Acres". Mr.Johnson indicated that the Board must determine what is reasonable compensation for this termination of HP easement. A Board member asked if any funds are returned to the County, would they be returned to the Historic Preservation Trust Fund and made available for this year's grant applicants? Mr. Barilla stated it was unlikely that the returned funds, if any, would be made available to applicants in the 2021 funding round. More likely it would be next year (2022) when any returned funds could be made available to applicants.

The Board was asked to form a sub-committee of 3 or 4 members to meet once via Webex to review the Township's request, including compensation and public access, etc. Members Engelbart, DeBiasse, Solu and Gotthelf volunteered to serve on the sub-committee and agreed to meet on May 13, 2021 at 1:00 p.m.
