OPEN PUBLIC MEETING STATEMENT

Chairman Thomson stated that, in accordance with the Open Public Meetings Act, adequate notice of the meeting had been provided and filed with the Town of Morristown,

the Morris County Clerk, the Daily Record and the Star Ledger.

Chairman Thomson read the virtual meetings statement.

PUBLIC COMMENT

There was no public comment.

APPROVAL OF MINUTES

NEW BUSINESS – Diversion Requests

- Harding Township adoption of a resolution memorializing Committee action on a
 Major Diversion located on a portion of the Glen Alpin property (Block 34 Lot 1) in
 Harding Township
 - On a motion by Nita Galate, seconded by Jaki Albrecht, the committee recommended approval of the Glen Alpin Diversion resolution to memorialize the committee's recommendation of approval as detailed in the May 27, 2021 special meeting minutes. - 2. Continued discussion of Parsippany-Troy Hills Township's request for a Minor Diversion located on a portion of the Smith Road Sheep Farm property (Block 736 Lot 9.01) Ms. Karen Benson provided a brief PowerPoint presentation which provided background on the proposal and addressed the committee's additional questions. The Parsippany Water Dept. proposes to divert a 0.164-acre portion of Block 736 Lot 9.01 to construct a replacement well, pump house and access drive to support the Township's drinking water system. Lot 9.01 is part of the Smith Road Sheep Farm project (Block 736 Lots 9.01 and 9.02) comprising a total of 4.98 acres, funded in part with an open space grant of \$350,000 in 2005. Ms. Benson provided the history to the project and reviewed the project timeline to date. In 2017, well 20 experienced capacity and water quality issues and rehabilitation was not sustainable. The search for a replacement well ensued for two years. During 2019 and 2020, at least

14 parcels, both publicly and privately owned, were evaluated for a replacement well. Ms. Benson reviewed the replacement well siting criteria and also parcels evaluated at the request of the NJDEP Green Acres program as part of the alternatives analysis. She noted per the email included in the information package that, barring any unforeseen issues with Part 2 of the final application, NJDEP staff intends to recommend approval of the minor diversion. One reason cited was that the alternatives analysis demonstrated to Green Acres' satisfaction that there is no feasible, reasonable and available alternative for this project.

Other questions previously asked by the committee were also addressed. Parsippany representatives stated they were open to offering the current well 20 well site as a replacement in lieu of compensation, but that financial compensation could also be used. The new replacement well would need to first be fully operational and this could take a few years. Mr. Patrick Cole stated the design of the new well house was chosen to look like a residence to match the aesthetic of the neighborhood. He also detailed the footprint of the physical volume needed by the equipment that would need to enclosed by the structure and visually compared the proposal to more industrial structures used elsewhere in the township. Ms. Diane Hickey detailed how the financial compensation in lieu of replacement land was calculated to arrive at a figure of \$11,619. Mr. William Johnson, Esq. stated that any future diversions before the committee would need to follow reimbursement guidelines per the adopted trust fund rules in place at the time, on a case by case basis.

After Parsippany's presentation, the committee asked additional questions. Mr. Jay Thomson had questions about the distribution of the well water which were addressed by Mr. Cole. Ms. Suzanne McCluskey stated the house is used by the soccer club but did not see any fields on the property. Representatives confirmed there were no soccer fields on the property. Ms. Laura Szwak inquired about properties evaluated in the alternatives analysis and specifically why certain ones lacking open space restrictions were not evaluated with site borings for suitability for the replacement well as well as certain private lots. Ms. Benson addressed her questions and advised the lots without open space restrictions had other constraints, including being within the zone of influence of another well, and private lots were out of the aquifer. Discussion ensued about the replacement site and future use should the replacement well no longer be used. Parsippany representatives stated that after performing the multi-year alternatives analysis for siting the replacement well, they hoped it would have a life span of fifty plus years; however, should the well no longer be used, they would be open to having the area revert back to open space.

Closed Session:

At the conclusion of all committee questions, all members of the public were moved to the lobby. On a motion by Nita Galate, seconded by Betty Cass-Schmidt, the committee entered into closed session at 7:59 PM to discuss the minor diversion request from Parsippany-Troy Hills Township.

Return to Open Session and Action as a Result of Closed Session:

The committee returned from closed session at 8:28 PM. All members of the public were returned to the meeting from the lobby. On a motion by Nita Galate, seconded

by Jaki Albrecht, the committee recommended approval of the Township of Parsippany-Troy Hills Water Utility's minor diversion request of a 0.164-acre portion of Block 736 – Lot 9.01 to construct a replacement for well 20, pump house and access drive to the Board of County Commissioners. The committee also recommended approval of \$11,619 as the financial compensation to Morris County for the diversion. Additionally, Parsippany represented they were amenable to having the diverted area revert to open space should the replacement well no longer be used. The committee recommended this condition be included in the recommendation to the Commissioners, and that should it occur there would be no financial compensation back to Parsippany.
