It is important to remember that the armistice, while it stopped hostilities, was not a permanent peace treaty between nations. Hostilities continued to erupt.

To qualify for listing in the Morris County Veterans Compendium, a veteran must be born in Morris County or lived in the county for ten years. Veterans who meet the criteria but are now retired out of state qualify for addition.

Korea: Forgotten Wars.

Korean War June 25, 1950 - July 27, 1953; DMZ Wars October 5, 1966-December 3, 1969, and Veterans of "The Z".

South Korea (Republic of Korea) v. North Korea (Democratic People's Republic of Korea)

Supporting: United States Supporting: China, Soviet Union

A unified Korea had been occupied by the Japanese empire since 1895, leaving Korea in a state of limbo when Japan was defeated in the World War II. Korea was eventually split in two - with the Soviets (communist) occupying the north of the "38th parallel north" – a line of latitude on maps – and the south controlled by a United States military administration.

Years of increasingly bloody incidents on the border, the Republic of Korea (ROK) was invaded by North Korea (DPRK) on June 25, 1950. General MacArthur deployed U.S. troops to South Korea and the war seemed to be winding down, however, the Chinese sent 200,000 troops to North Korea in October of 1950 and forced the U.N. troops to withdraw back to the 38th parallel after winning the Battle of the Ch'ongch'on River.

Although the armistice was implemented July 27, 1953, North Korea and South Korea never signed a peace agreement, meaning technically, the Korean War is ongoing.

In December of 2021, North and South Korea, the United States, and China agreed in principle to declare a formal end to the Korean War.

As of this writing in June 2022, talks have not begun.

The Korean War (1950-1953) began as a police action, which gradually became a war. The slow-paced escalation allowed Americans to concentrate on the larger implications of the Cold War in Europe and not on the Korean conflict. Just a few years out of WWII, the United States population feared a return to wartime rationing and hardships. American citizens were generally back to a pre-war lifestyle in the '50s and unenthusiastic at the prospect of another conflict requiring full-on mobilization.

North Korea continued its assault on South Korea years after the Armistice of 1953.

During the Vietnam War and the tensions of the Cold War, the American press and public paid scant attention to the continuing series of attacks by North Korea, designed to test the willpower and resolve of the United States not to enter another full-scale war.

Hostilities continued to produce a bloody powder keg of incidents.

Assaults included guerrilla warfare, sabotage and terrorism directed against the ROK and American troops serving in the "Zone"- the aggression at its most deadly occurring between 1966-1969.

43 Americans were killed, 111 were injured and 85 were captured in this period.

In August 1976 the "Gardening Job" drew the nation's attention. Briefly.

American and South Korean troops were pruning a poplar tree that stood in the middle of "The Zone".

North Korean soldiers attacked the landscape detail, killing two United States Army officers.

The White House responded with "Operation Paul Bunyan" - a show of force that included hundreds of U. S. soldiers, B52s, helicopters, and tanks. Soldiers cut off every branch, leaving only the trunk standing.

Eager to put this military chapter behind them, the valor of Korean veterans and veterans of "The Z" were largely relegated into silence.

Today, Morris County remembers the veterans who served in Korea.





Battle Conditions

The weather in Korea mimics that of the United States east coast-except that it is more intense. Summers are hotter and more humid, and the winters are more bitter, due to winds blowing in from Siberia.

Many Korean War vets in Morris County have discussed the bitter cold, rather than the oppressive heat.

One of the most brutal battles of the Korean War was the "Battle of Chosin Reservoir".

The battle nicknamed "Frozen Chosin" raged from November 27 to December 13, 1950, in the intensely bitter cold of -54 F.

Soldiers suffered frostbite, jammed weapons, and frozen rations. Reliable transportation was unknown in that frigid environment. It was routine for soldiers to dress in three layers, making mobility almost impossible-hindering further efforts to transport supplies carried on their backs.

Described as "getting creative", one Korean War vet explained pouring gasoline into empty 105mm shells and lighting them, using them as heaters.

The Tiger Death March and the "Johnnie Johnson List"

In October 1950, a North Korean Army major referred to as "The Tiger" took command of more than 700 American service men who had been captured and interned as prisoners of war.

In August 1953 following the signing of the armistice, only 262 of these men returned alive. One of the survivors, Army PFC Wayne A. "Johnnie" Johnson, risked his life during his imprisonment by secretly recording the names of 496 fellow prisoners who had died during their captivity.

The Department of Defense (DoD) debriefed all returning American POWs concerning their knowledge of those who did not return from the Communist prison system.

Private Johnson's painstakingly written record was a major contribution to this effort and helped to determine or confirm the fate of many POWs.

In 1995, a Defense Prisoner of War/Missing Personnel Office (DPMO) analyst learned about Johnson's Tiger Survivors List while attending a Korean War Ex-POW reunion in Sacramento, California.

DPMO analysts then located intelligence archives which contained Johnson's original debriefing report as well as other POW reports corroborating his information. Among these records was also found a debriefer's handwritten memorandum recommending that Private Johnson be recognized for his bravery.

This information was forwarded to the Department of the Army, and in 1996, Private Johnson was awarded the Silver Star, the nation's third highest military combat decoration for Valor.

The name Frederick William Aten, of Butler, is on the Johnnie Johnson list.

The U.S.O.




At the end of WWII, The United Service Organization-or USO- disbanded.

In 1950, with the United States entering the Korean War, then-Secretary of Defense, George Marshall, and Secretary of the Navy Francis P. Matthews requested the U.S.O. be restored

"to provide support for the men and women of the armed forces with help of the American people."

By 1952, the USO was serving the needs of 3 million troops, and that included the return of touring U.S.O shows

Hope would spend a total of forty-eight Christmas Days over-seas with troops from WWII, Korea, Vietnam, and his last tour in 1990 during Operation Desert Shield.

Morris County veterans, regardless of conflict, mention how much the U.S.O shows boosted their spirits.

One veteran stated:

"I just hope Bob knew how much he meant to us."

Aftermath: Dr. H. Richard Hornberger



Born in Trenton, New Jersey, Dr. Hornberger attended Bowdoin College, then Cornell Medical School.

A specialist in Thoracic Surgery, Dr. Hornberger was drafted into the Army and sent to Korea, attached to the 8055th Mobil Army Surgical Hospital or MASH.

These seven outfits were just what the name implied, ready to travel or "bug out" at a moment's notice to assist the wounded. Often the surgery tables were sawhorses with the stretcher laid across them.

Relocating to Maine after the war, Dr. Hornberger's time in service inspired him to recount that period of his life by writing three novels.

Published under the nom de plume Richard Hooker, MASH was published in 1968.

The main character, Dr. Benjamin "Hawkeye" Pierce, is based on Dr. Hornberger and the escapades of his fellow unit members, living in a tent they named "The Swamp".

MASH the novel was quickly adapted into a film in 1970.

MASH was later adapted into a television show, running from 1972 to 1983.

Although Dr. Hornberger approved of the film version of his work as a true representation of his intent when he wrote the novel, he famously did not care for the television series feeling it was anti-military and hardly watched it.

According to the doctor's son, William:

"My father didn't write an anti-war book, it was a humorous account of his work, with serious parts thrown in about the awful kind of work it was, and how difficult and challenging it was."



Aftermath: The Korean War Memorial

The Korean War Veterans Memorial on the National Mall in Washington, D.C. was dedicated on July 27,

Nineteen stainless steel statues were sculpted by Frank Gaylord of Barre, Vermont, each figure is nearly seven feet tall. The figures consist of 14 Army, 3 Marine, 1 Navy and 1 Air Force member.

The statues stand in patches of Juniper bushes intentionally separated by polished granite strips, giving the appearance of the rice paddies of Korea.

The troops wear ponchos covering their weapons and equipment. The ponchos seem to blow in the cold winds of Korea.

The statues depict a constant vigilance, with the heads facing in all directions.

A mural wall is adjacent, engraved with the names of Korean veterans KIA/MIA.

Embedded in the wall panels are over 2,000 images taken during the Korean War.

The memorial includes pavers with the names of U.N. countries that participated in the conflict.

Aftermath: Nuclear Capabilities

North Korea remains an isolationist country and one-party state (Worker's Party of Korea) with little accurate information released across its borders. Media is state-run and strict protocols apply when visiting North Korea.

It is suspected that North Korea began its nuclear weapon capabilities experimentation in the 1980s.

On October 9, 2006, under the country's then-leader, Kim Jong-il, referred to as "Fearless Leader", North Korea announced it had successfully tested a nuclear weapon.

Difficult to discern North Korea fact from fiction, the United States Geological Survey announced they had detected a tremor of 4.2 magnitude on the Korean Peninsula.

April 11, 2022, marked the tenth anniversary of the present Supreme Leader Kim Jung-Un, son of Jong-il, assumed control of the North Korean people.

The month prior, Jung-Un launched an intercontinental ballistic missile (ICBM).

Due to ruling by threat, intimidation and torture, the region remains unstable, dating back to Kim Ilsung, Jung-Un's grandfather, who founded the Worker's Party of Korea in 1948.



Aftermath: The Joint Security Area

North Korean soldier peers into the JSA conference room where a South Korean soldier stands guard.

The Joint Security Area (JSA) occupies the site of former farming village Panmunjom.

This is the only location where North Korean, American and South Koreans face each other.

Once highly fortified, both North and South Korea began the process of removing landmines and guard towers in 2018.

The crew, eighty-two, as one died in the attack, were moved to two North Korean P.O.W. camps. Eventually the remaining crew were released, but the U.S.S. Pueblo remains the only American ship captured on display. She is anchored in Pyongyang, North Korea, maintained as a ship museum at the "Victorious War Museum".



Here is one of the men who made the Slattery Detachment a well known name both locally and nationally. Sure, there were a few others, but Pete Gallo stepped up whenever there was a need to get something done. He was the detachment Commandant from 2003 to 2008 and again from 2012 to 2013. In fact, he was the Slattery Detachment, Marine of the Year in 2004 and the Department of New Jersey Commandant of the Year in 2005-6.

Let us take a look at this great Marine. Pete joined the Marines during the Korean War and served in Korea in 1952. His job was that of a cook. In fact, here is the menu for the 1st Marine Divisions 1951 Thanksgiving Day dinner that he prepared. It looks like they could have fed the entire division with all that food. And to finish it all off, they had mincemeat pie, fruit cake and pumpkin pie plus a little take-a-way of fresh apples and oranges. We should have tapped him to do the cooking for our socials.

Pete left the Marines and came back to New Jersey where he married the love of his life Marie and moved into their home on Belaire Avenue in Cedar Knolls. There the young couple raised a family and enjoyed life as Pete worked for the Hanover Police Department and Marie taught school.

In 1956, Pete became involved with the American Legions Post 155 and was the Post A djutant at one time. On September 1, 1999 Pete joined the Marine Corps League Slattery Detachment located then in Morris Plains. A week later he applied for Life Membership in the MCL. Since then he has been active building up the detachment in so many ways.

He lead the way, along with Mario Monaco, to create the Slattery Marines Care which has assisted many Marines and Marine families. Pete, with the help of Eddie Neas, created the monthly trips to Bethesda and Walter Reed Military Hospitals to visit the wounded. In 2005, he contacted Rodney Frelinghuysen and got Rodney to get Amtrack to make available the passes for the detachment trips to Washington, DC.



Pete was the co-editor for a long time of the detachment monthly newsletter, The Slattery Sidelines. He was the Chairman of the Hanover Veterans Alliance memorial development committee. This committee created and installed the memorial stone to the Hanover Townships veterans killed in action of all wars. In 2019, Pete was the Parade Marshall of the Hanover Memorial Day Parade. This is only a small portion of what Pete did.

Yes, Pete was a one-man detachment.

Psychological Warfare: Propaganda leaflets

Sgt. Kostka's archive of images during the Korean War contains a propaganda pamphlet produced by North Korea.

These pamphlets were dropped by plane or left in stacks for American soldiers to find. The goal was to demoralize troops from fighting, encourage the troops to surrender or flip sides.

Propaganda was and is continued to be used by militaries and governments around the world.

In 2020, North and South Korea dropped leaflets encouraging citizens on both sides to defect.

During the Korean War, North Dakota native Albert G. Brauer served as Chief of the Projects Branch, Psychological Warfare Division, G3 section. He was responsible for overseeing the creation of propaganda pamphlets that were airdropped over North Korea.

The themes of war propaganda are similar: The soldier is forgotten, will leave a widow and fatherless children, the leaders of the soldiers' country do not care about the conditions the soldiers are enduring.





The flyleaf: "Somewhere in Korea far away from home for what and for whom are you going to shed more blood!!! U.S. delegation is stalling the armistice talks and forcing you to shed more blood!!! If you are Killed in Action this leaflet can be used as a SAFE CONDUCT PASS to come over to the KPA (Korean Peoples Army)"

Interior: "In the U.S.A. the ruling circles, drinking toasts and dancing, are making a night of it while you are shedding your blood and falling on the Korean front. Who, then, will mourn your death no one but your wives, children, parents and sweethearts!!!"







"He served in Korea with the 25th Division, 14th Tank Battalion from April 1, 1952 to February 1953. The tanks were used as forward artillery along several fronts and Saks said three of the estimated 300 soldiers in his battalion were killed.

The period from November 1951 until the last days of the war was marked by a strategy known as "position warfare." Rather than mounting offensives, the U.S. forces mapped out sectors that they would defend against any enemy aggression, according to military records.

Saks said the service was not difficult and in fact that after 1951, there was little action and plenty of good food for the soldiers.

"There was more food than you can eat," said former Sgt. Saks. "As far as anything lacking, no way."

He also had little bad to say about the notoriously brutal Korean winters.

"To me, the weather was like New Jersey," said Saks, who was raised in Caldwell and moved to Brookside in 1974."





Born in Yeadon Pennsylvania on July 20, 1929, he graduated as a Machinist from The Williamson Free School of Mechanical Trades in Media Pennsylvania before being inducted into the Army April 11, 1951. Upon returning from Korea on April 17, 1953, he was transferred to the Army Reserves and honorably discharged on May 6, 1957.

Robert served in Korea as a Private First Class with the 7th Infantry Division also known as the Bayonet Division. The 7th Infantry Division defended the line from Mundung-ni to the rim of "Punchbowl, October 1951 thru March of 1952. The 7th Division also assaulted and captured "Triangle", "Sandy" and "Jane Russell" hills in October of 1952. Bob was a small arms repairman who put his Williamson machinist skills to work. When the parts for weapons were in short supply, Bob convinced his commanding officer to set up a machine shop so he could fabricate the needed parts. He received the Korean Service Ribbon with three campaign stars and the United Nations Service Ribbon.

After being honorably discharged, he met and married Anita and settled in New Jersey. Initially, Bob worked in the field of industrial pollution control where he became a recognized authority in paper mill wastewater treatment and an Officer of Whippany Paper Board Company. In 1973 he founded Shaw Built Homes and became a leader in the home building industry. He served as president of the Builders

Association of Sommerset and Morris and was inducted into the New Jersey Builders Hall of Fame. In 2000 he was honored as a distinguished alumnus of the Williamson Free School of Mechanical Trades.

Bob inherited a lifelong love of fishing, hunting, boating, and the outdoors. He shared this, along with his enthusiasm for flying, antique cars and photography, with his family. In 1967 the family settled in Mountain Lakes, where Bob liked to say that they were on vacation 365 days a year.

Bob had a daughter and two sons with his wife of 60 years and four grandchildren.

On May 25, 2022, Mr. Robert Shaw's posthumous Morris County Distinguished Service Medal was accepted by his son, Morris County Commissioner Stephen Shaw.

At 19 years old, Mr. Wilhide joined the United States Army with his best friend, Rollo. After Basic training in Fort Knox, Kentucky, he shipped to Korea in 1951. During their tour, Pfc. Wilhide delivered supplies from the air base in Chunchon to the troops on the front lines (sometimes in extreme winter conditions). When Wilhide returned to Baltimore on a military plane, it crashed after dropping him off, killing all on board. The last part of his hitch in the U.S., he was assigned to an anti-aircraft battery defending the White House and the Capital in Washington, D.C. until his honorable discharge. Upon returning home, he graduated from Johns Hopkins University and received his Diploma from Dwight Eisenhower in 1958.


