#### **Medication Assisted Treatment (MAT):**

NJ DHS to expand the availability of Medication that Supports Recovery from addiction. DMHAS has notified treatment providers that it will award five regional contracts not to exceed \$800,000 to expand the life-saving medicines throughout the State. This is a part of a \$4-million-dollar grant program.

#### **Quarterly Provider Meeting:**

DMHAS held a Quarterly Provider Meeting on 3/11/21 with presentations regarding Incident Reporting, the NJ Evidence-Based Practices Initiative, and the State Tobacco Control Community of Practice partnership between DOH and DMHAS.

- Incident Reports-reviewed when reports should be initiated; shared that training is available for agencies upon request.
- NJ EBPI-consultation is available to agencies to ensure agencies fully incorporate EBP into the full infrastructure and effectively train all staff. Four

- agencies have completed the Initiative. The program will be continuing for Phase 2, and Phase 3 and another RLI will be issued to choose additional providers for this opportunity.
- DMHAS and DOH partner for the State Tobacco Control Community of Practice to address smoking amongst mental health consumers.

The next QPM will meet on July 8, 2021, to allow the budget to be finalized before the meeting. As of now, the proposed budget will include increased funding for:

- Increase of fair market rates for DMHAS subsidies to increase current rates (currently, they are at 2018 rates).
- Pathway for psychiatric residencies (10 residencies in total) in community-based mental health and SUD programs
- Increased state aid for County Psychiatric Hospitals as their costs have increased over time.
- Additional DMHAS subsidies for CSS are allocated for those coming out of the State Psychiatric Hospitals (180 proposed).
- Additional DMHAS subsidies for CSS are allocated for the homeless, at risk of homelessness, or at-risk of hospitalization (20 proposed).
- \$2.2 million for a pilot program with the Administrative Office of the Courts for consumers with mental illness interacting with the criminal justice system

#### VI. Staff Reports:

#### Municipal Alliance Coordinator - Mr. Steve Nebesni

There are two 2021 applications that need to be retyped and resubmitted.

We are waiting on the 2022 allocation amounts to be announced from the Governor's Council on Alcoholism and Drug Abuse (GCADA.)

#### Addiction Services Coordinator – Ms. Rosalyn Suarez

- The next Stigma-Free meeting is March 16<sup>th</sup> at 2:00 pm.
- At the last State meeting, the Department of Mental Health and Addiction Services (DMHAS) discussed the Jail Medication-assisted treatment (MAT) Initiative
  - Partner with the Department of Correction, NJ Department of Health, Warden's Association, and PEW Charitable Trust Partner with John Hopkins
  - Opioid Use Disorder (OUD) services to assist inmates who are going through pretrial or jail
  - State and Federal resources are used to help the prisons to establish new MAT programs or enhance existing MAT services
- Legalization of Marijuana: Governor Murphy signed the legislation for recreational use on February 22<sup>nd</sup>. NJ is the 13<sup>th</sup> State to allow recreational marijuana
  - o To legalize adult-use cannabis

- An individual 21 and over can have up to 6oz of marijuana without facing any penalty
- o Limit the use of previous marijuana convictions
- State-licensed dispensaries, though it could be well over a year before sales begin
- o No selling or growing is allowed in NJ
- The Recovery Network offers outpatient services available to individuals statewide for the deaf, hard of hearing, and hearing loss who are experiencing SUD through telehealth. #### Mental Health Administrator – Ms. Amy Archer

Community Development Block Grant (CDBG) Coronavirus Aid, Relief, and Economic Security (CARES) Act funding, Mental Health Association (MHA) was awarded a contract to continue with the Suicide Prevention Program throughout 2021. MHA will continue to travel on Navigating Hope once a week to provide information to the community.

The Human Service Advisory Committee (HSAC) Needs Assessment was submitted to the State. The State has provided feedback that will be published but has not provided a publication date. As the information becomes available, it will be provided to the Board.

The Division of Aging, Disabilities, & Community Programming will be holding a COVID-19 Wellness Event for adults age 60 or older, and adults with Disabilities at the County Library on April 12<sup>th</sup> from 10:00 am – 1:00 pm. Home Bound senior or Adults with Disabilities that are unable to attend and would like to receive a kit (touchless tool kits, hand sanitizer, and reuseable masks) can call 973.285.6848 for assistance.

Senior-specific (age 75 and older) NJ COVID call center hotline - from 8:00 am -8:00 pm to register, schedule, and reschedule appointments - 856.249.7007.

Ms. Chelsea Whiting, Morris County Sheriff's Office, reported on a new initiative called the Hope Hub. Hope Hub, a comprehensive program that combines the expertise and resources of multiple public service agencies to help vulnerable and at-risk people find the assistance they need, from homeless solutions and addiction treatment to mental health counseling or a combination of services. Hope Hub is an expansion of the Hope One outreach program, a mobile substance use recovery and mental health initiative by which a team of specialists drives into Morris County communities to find and assist people in need of addiction counseling and mental health services. Hope Hub will expand on that formula by bringing a team approach, tapping the services of many different agencies and nonprofits to focus on vulnerable individuals' cases brought to their attention by various public service agencies or individuals. Spearheaded by Hope Hub Coordinator Officer Ms. Chelsea Whiting, Hope Hub will be a multidisciplinary panel made up of law enforcement members, social services, mental health services, healthcare providers, treatment providers, and recovery specialists. Individuals and

families struggling with problems referred to the Hope Hub panel will be connected to life-changing services. The multidisciplinary panel will determine what public services would best help an individual bring to their attention. The board will work together to determine if a situation requires a welfare visit or an intervention.
