



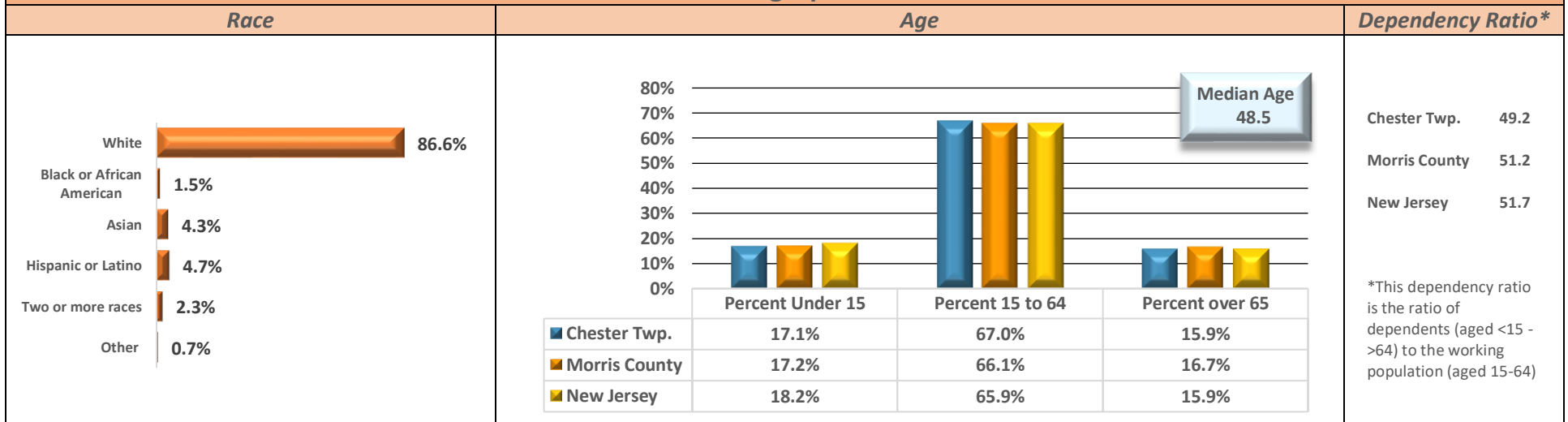

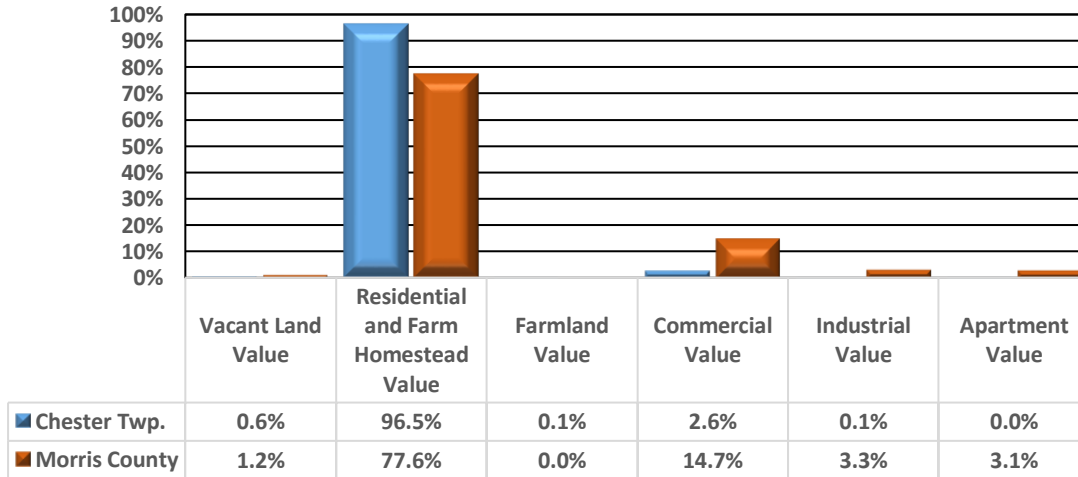

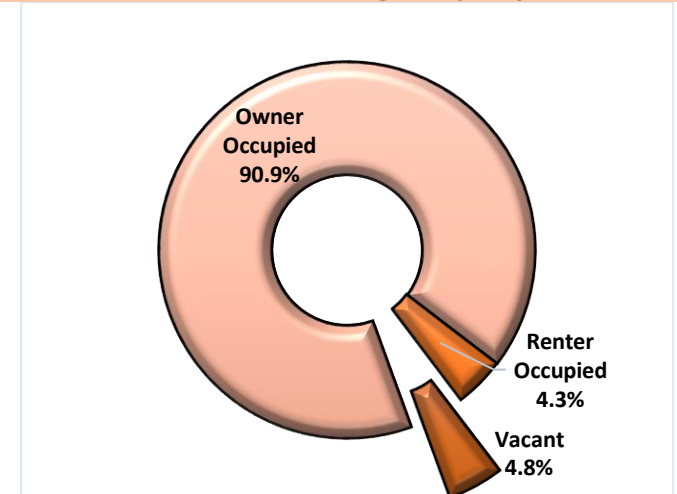

### Parcel Values as a Percentage of Total Value



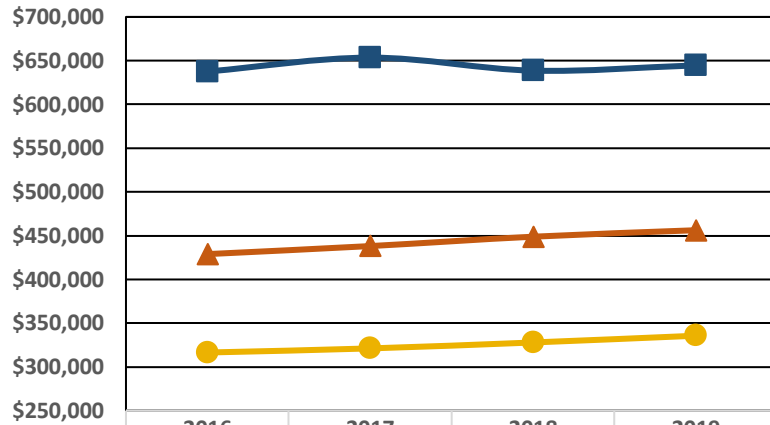
### Housing Occupancy

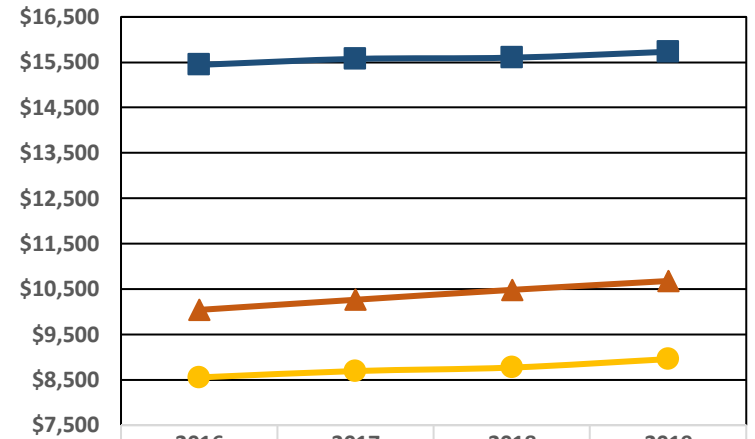

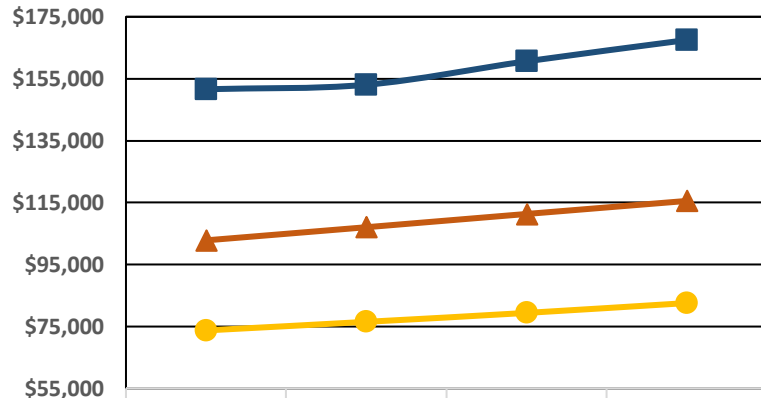

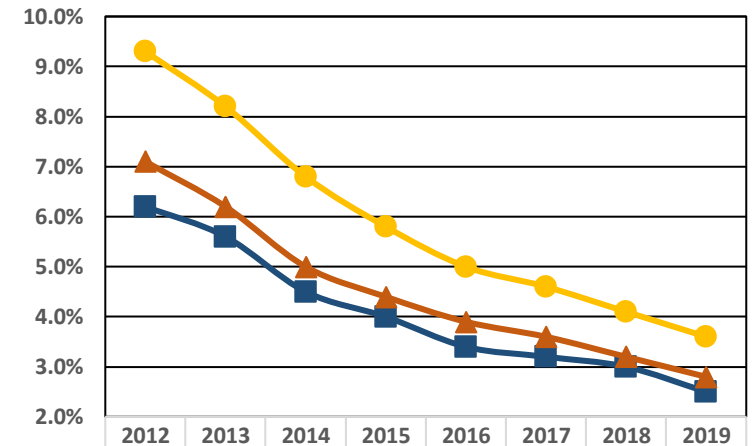

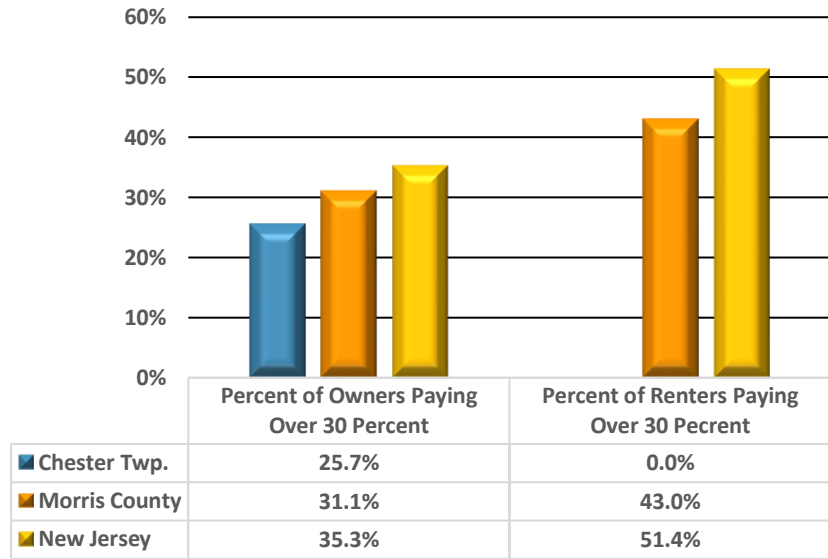

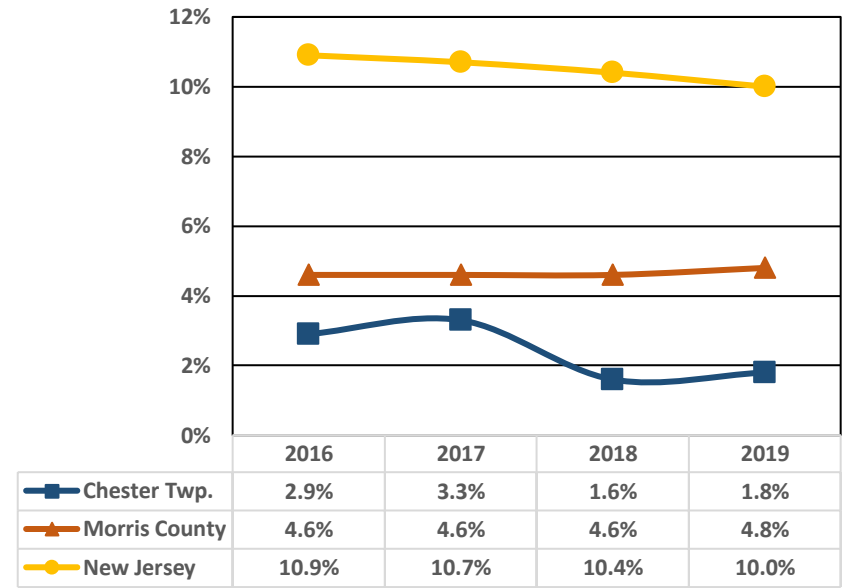

### Percent of Residents Paying More Than 30 Percent of Income on Housing

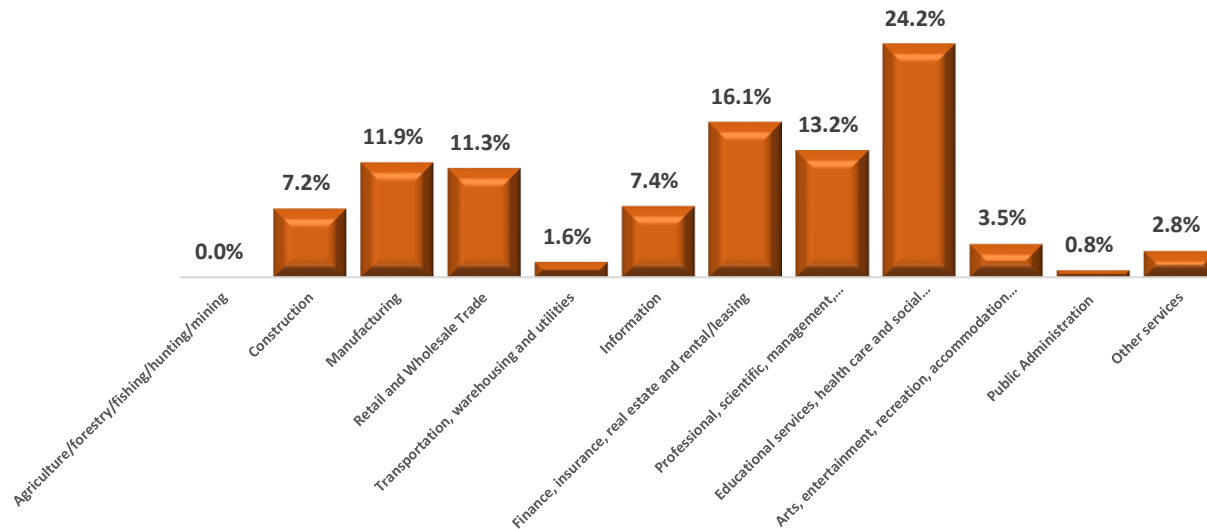


### Percent Below Poverty Level

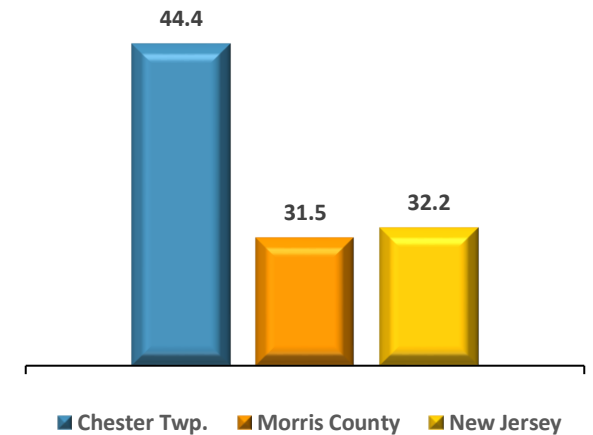

### Resident Workforce Employed by Sector



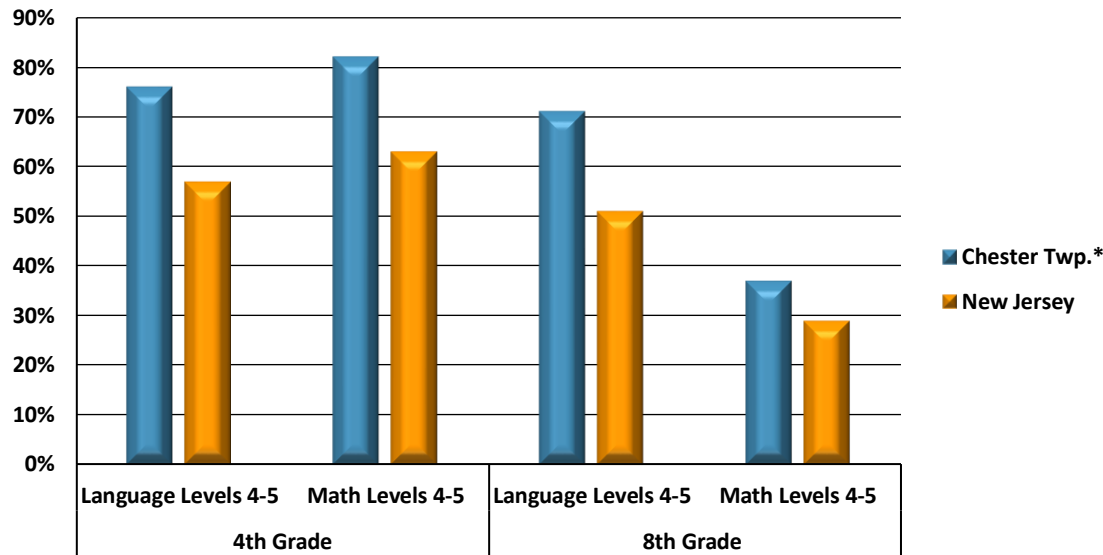
### Mean Travel Time to Work (minutes)



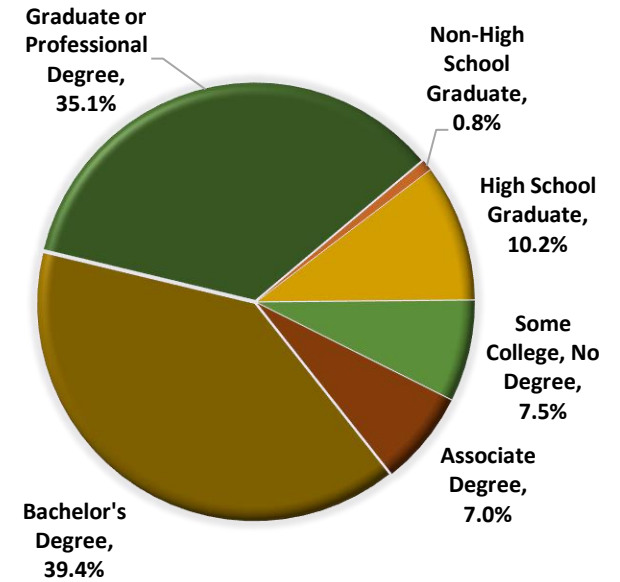

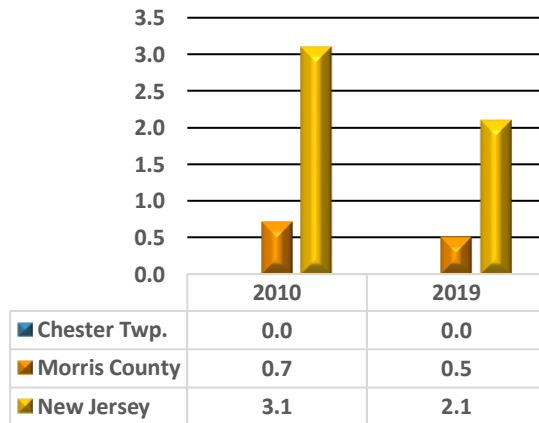
*Highest Level of Education Attainment (=>25 years)*



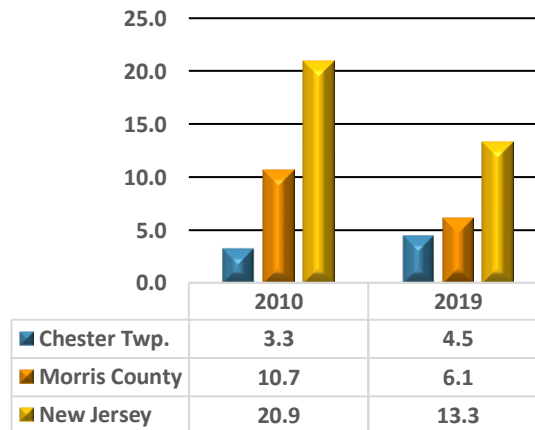

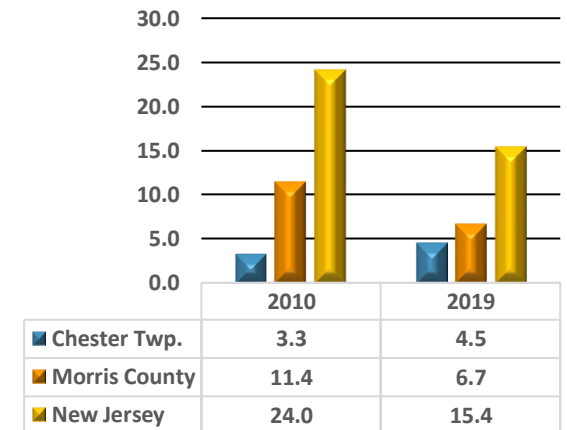
*Violent Crime Rate*
