**PLEASE TAKE NOTICE** that, in accordance with the Open Public Meetings Act, New Jersey Executive Orders and N.J.A.C. 5:39-1.1 to 1.7, the Board’s regularly scheduled meetings for 2026 will be held remotely, via Cisco WebEx video conference.

To participate in a remote public meeting, you may use the link or dial-in number that will be provided on the Office of Planning and Preservation’s website. [www.morriscountynj.gov/planning](http://www.morriscountynj.gov/planning) and the agenda prior to each meeting.

Upon entry, members of the public are automatically on mute until the public comment portion. When the meeting is open for public comment, you may request to be unmuted on WebEx by pressing the microphone icon. You may also press the “Raise Hand” button on WebEx or dial \*3 to raise your hand to request to be unmuted. Once the facilitator calls upon you, you may unmute yourself by pressing \*6 on the telephone keypad. While muted, you will still be able to hear the meeting participants. You will be addressed by name or the first 6 digits of your telephone number. You may re-mute yourself by pressing the microphone icon on WebEx or by pressing \*6 a second time. You can lower your hand by pressing \*3 on the telephone keypad or by pressing the “Raise Hand” button a second time. To make a public comment, you must state your name and address for the record. At the conclusion of your comment, you will be placed back on mute.
