



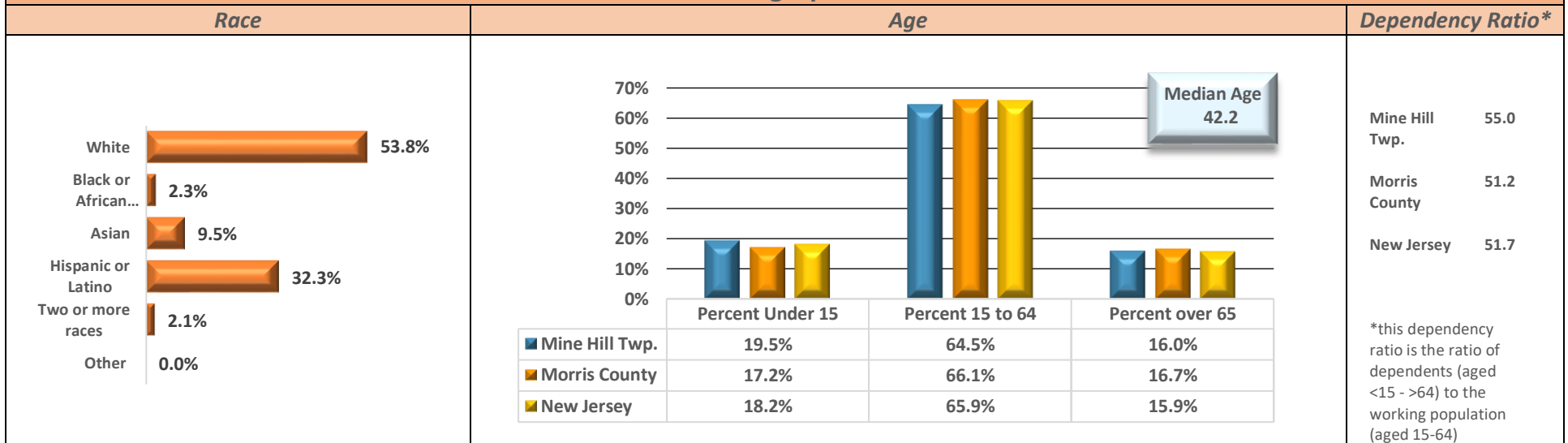

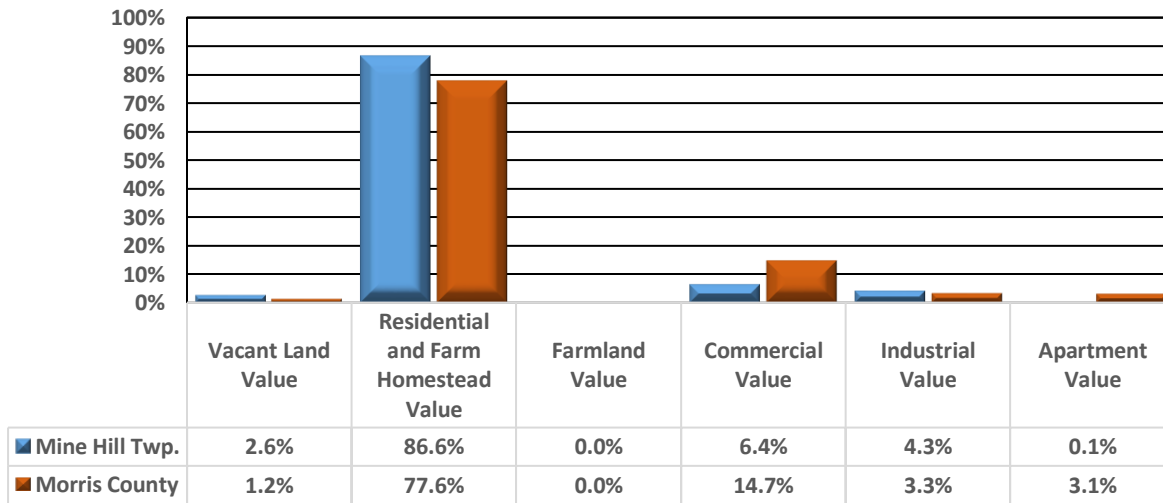

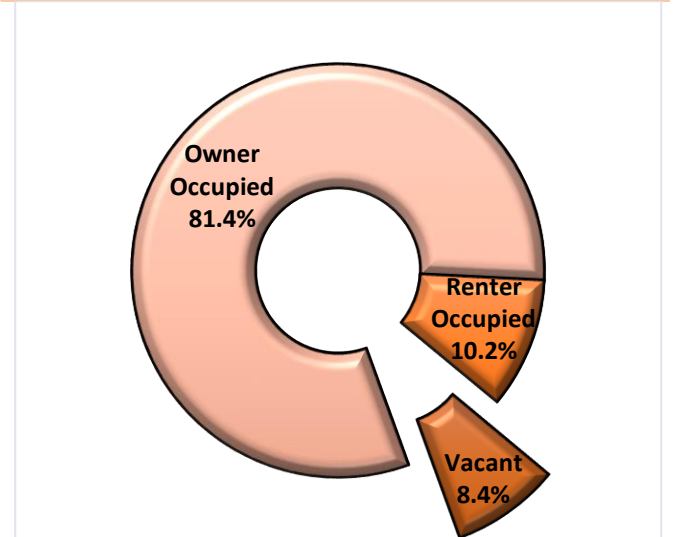

Parcel Values as a Percentage of Total Value



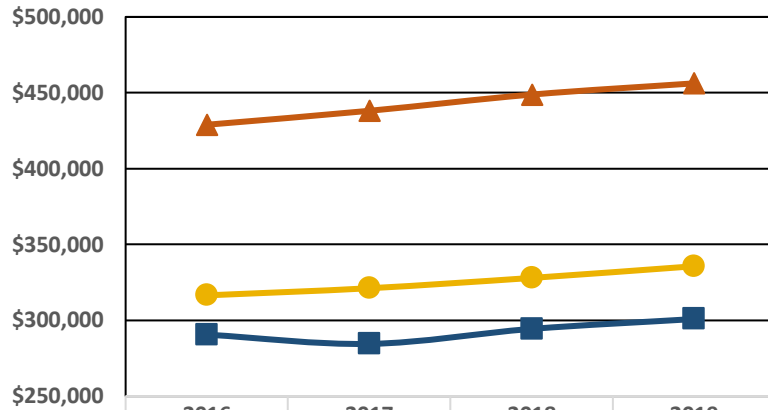
Housing Occupancy

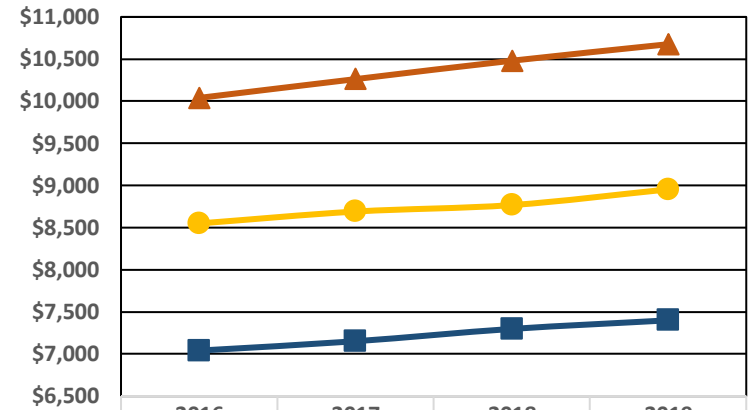

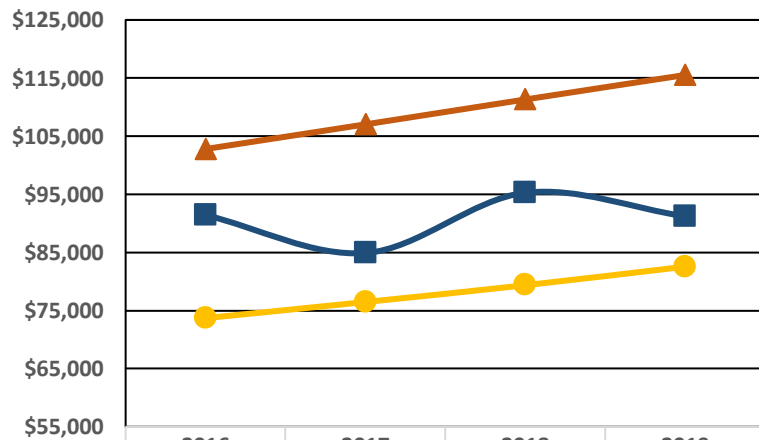

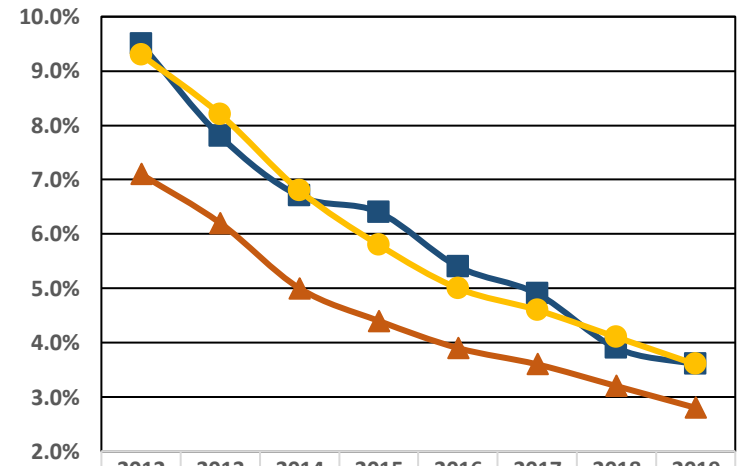

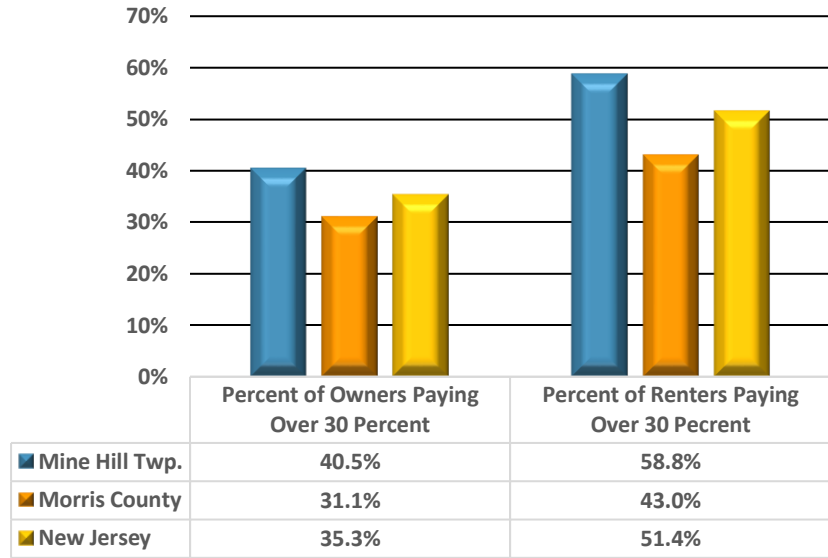

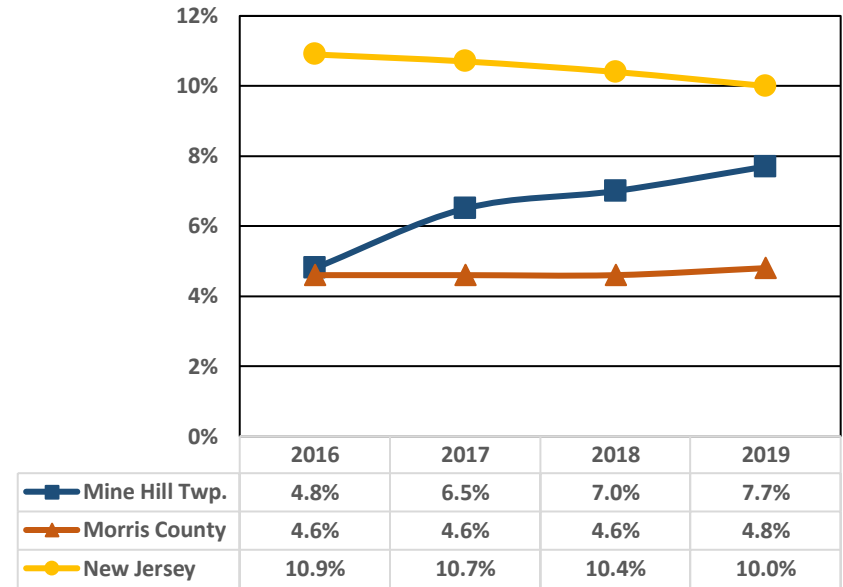

Percent of Residents Paying More Than 30 Percent of Income on Housing

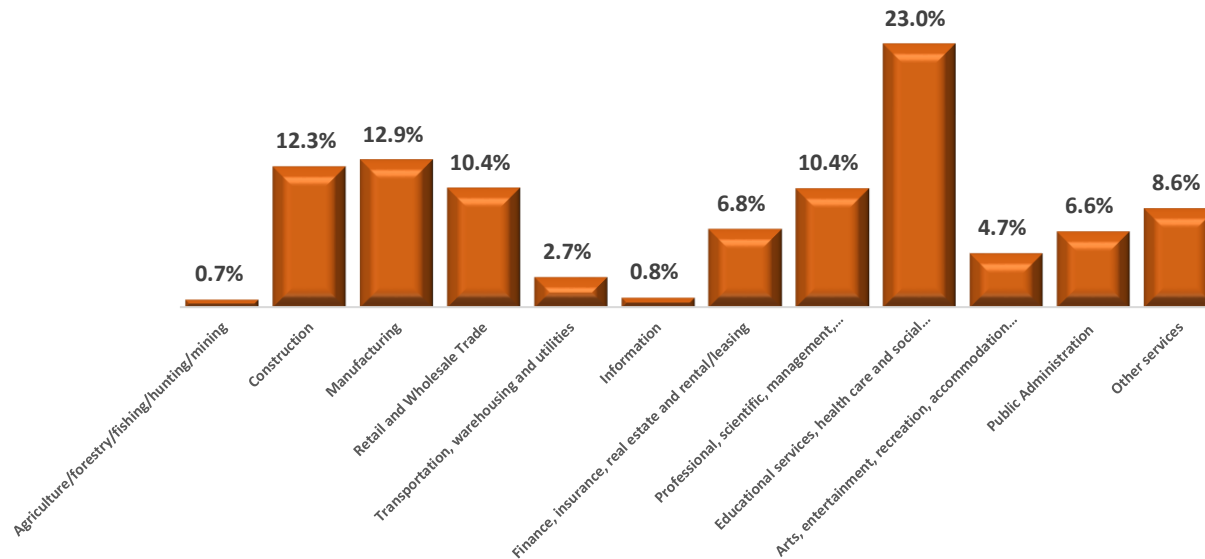


Percent Below Poverty Level

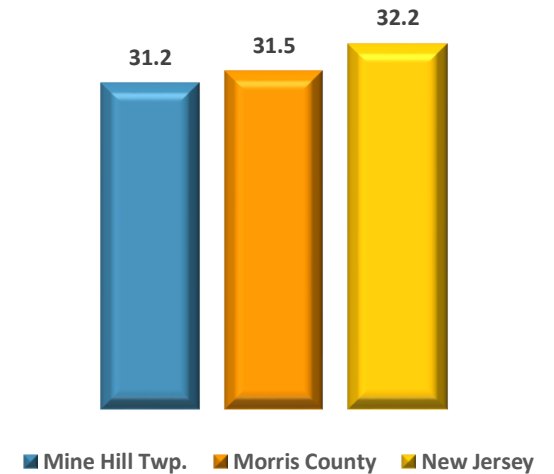

Resident Workforce Employed by Sector



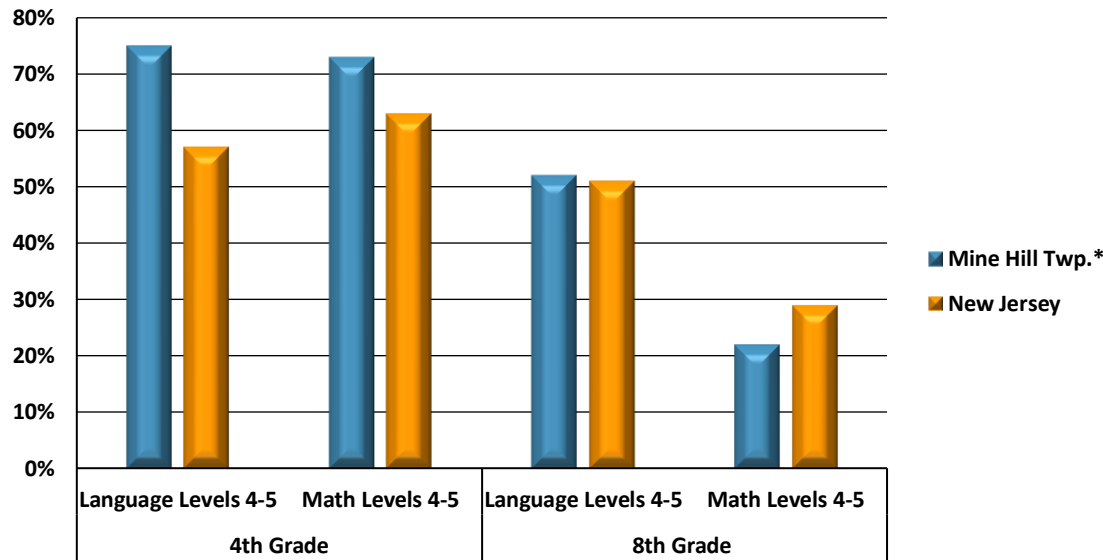
Mean Travel Time to Work (minutes)



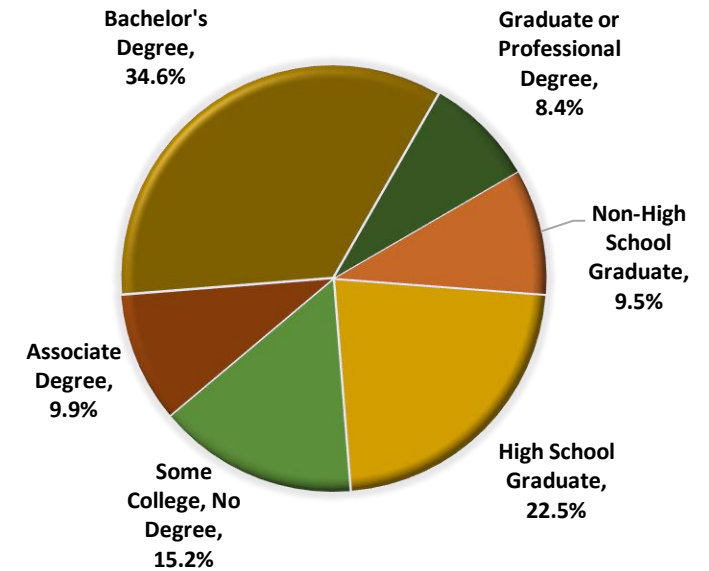

PARCC 4th and 8th Grade: Percentage of Students Meeting (Level 4) and Exceeding (Level 5) Expectations



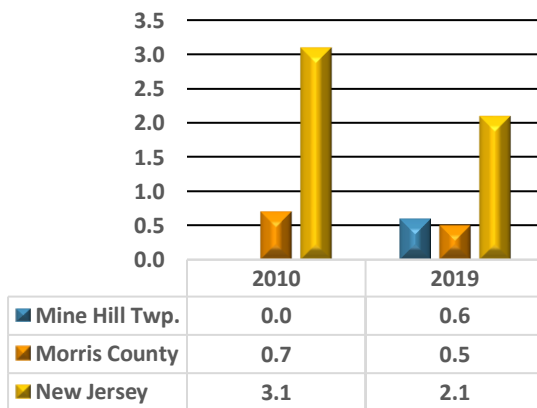
Highest Level of Education Attainment (=>25 years)



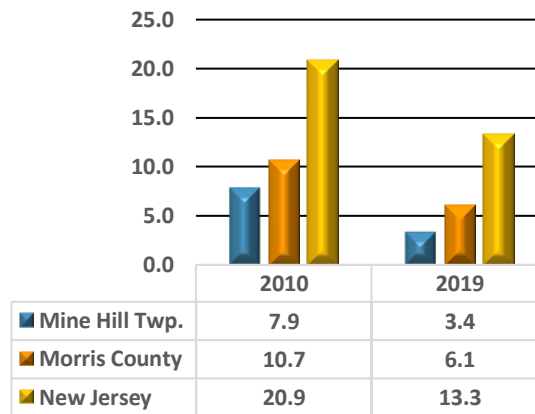

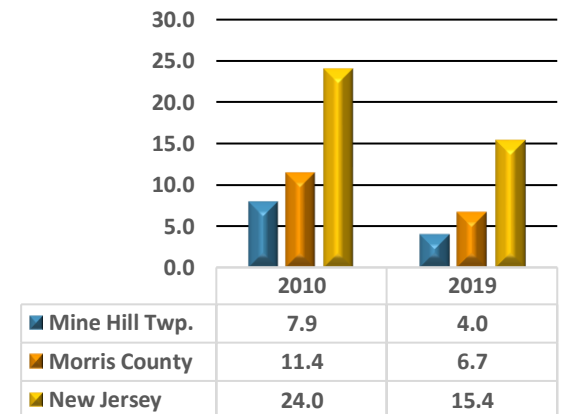
Violent Crime Rate
