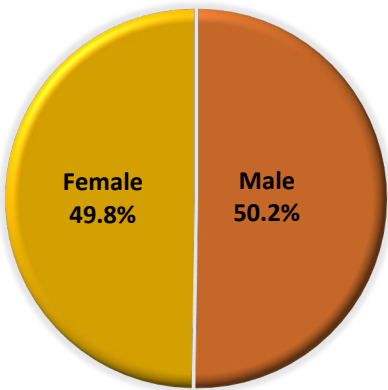
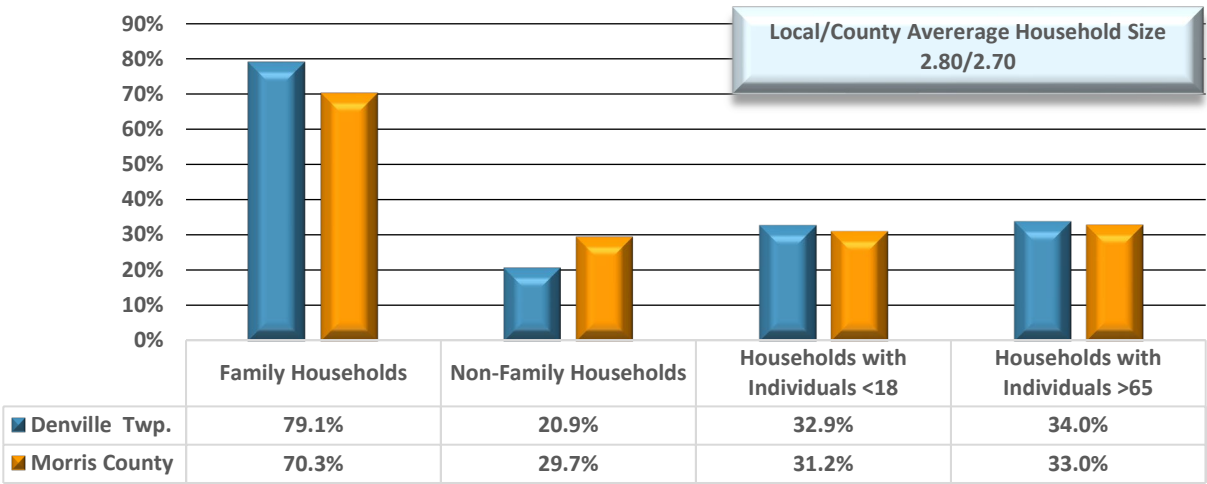

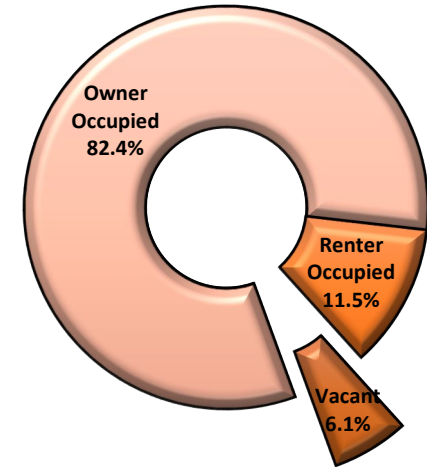
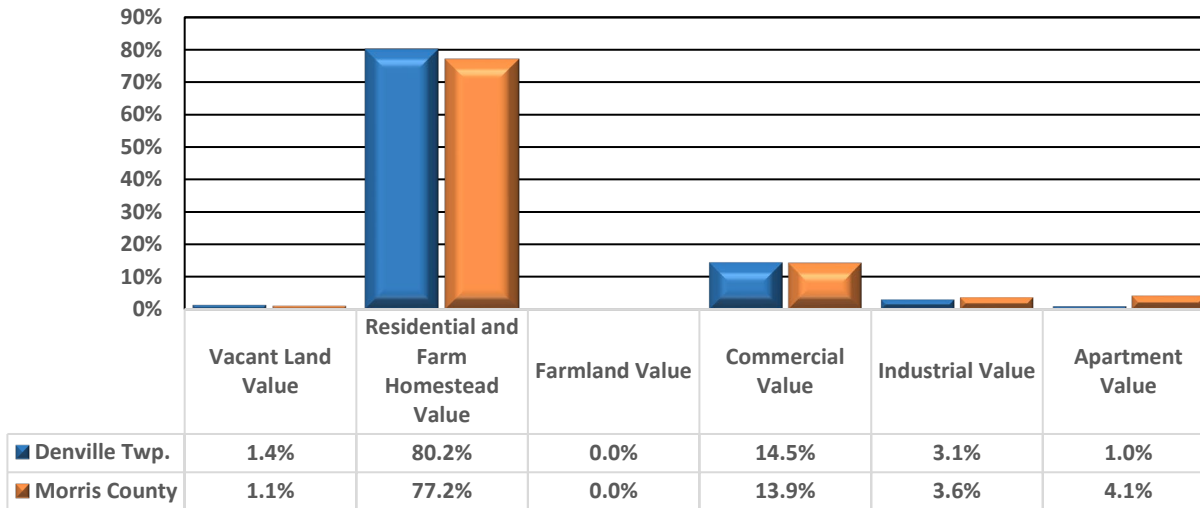

Parcel Values as a Percentage of Total Value

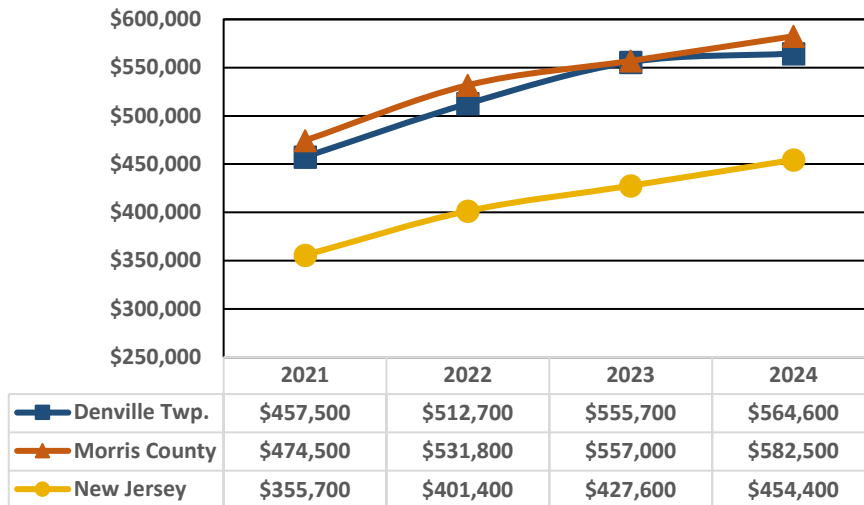
Housing Occupancy



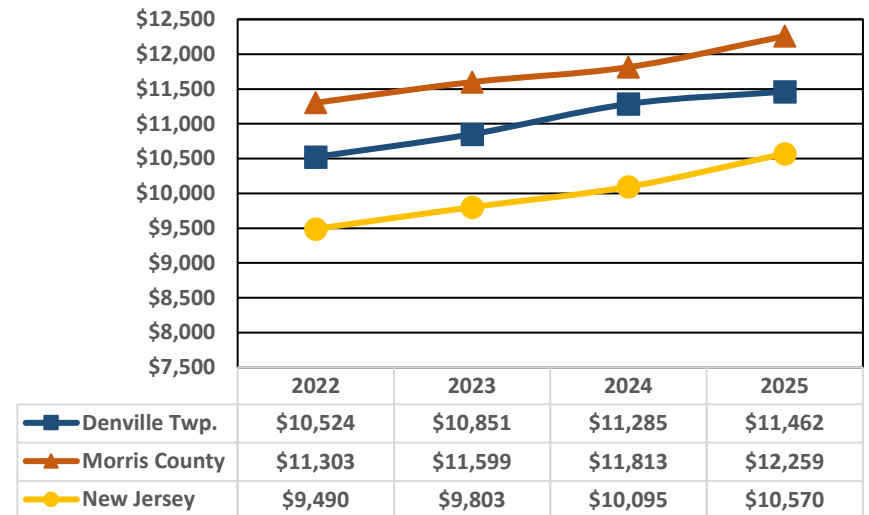

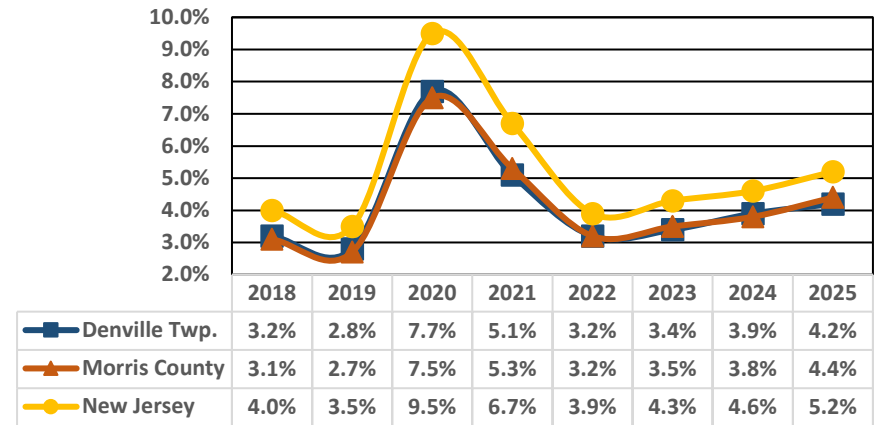
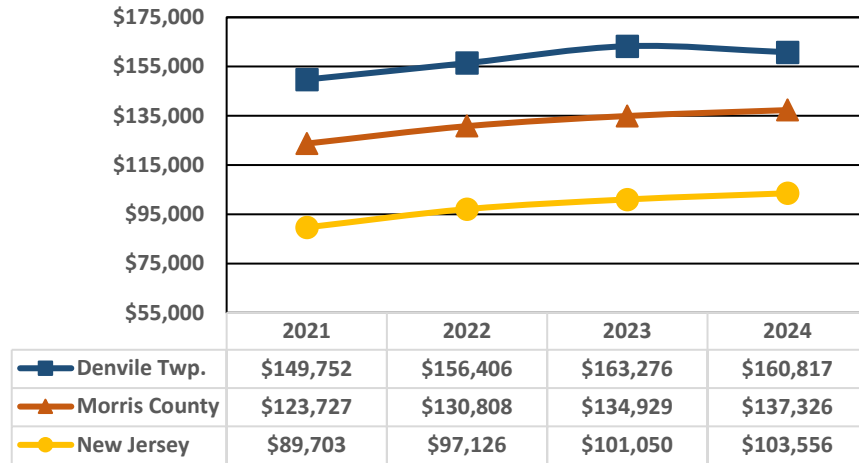

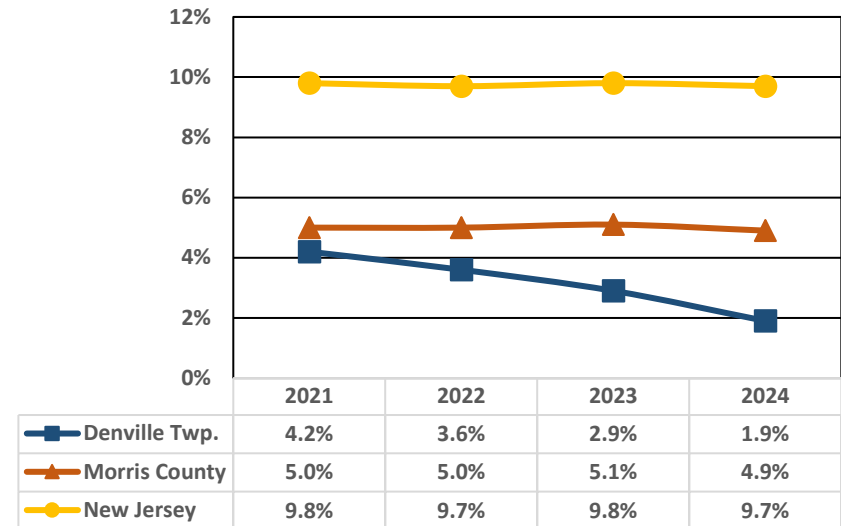
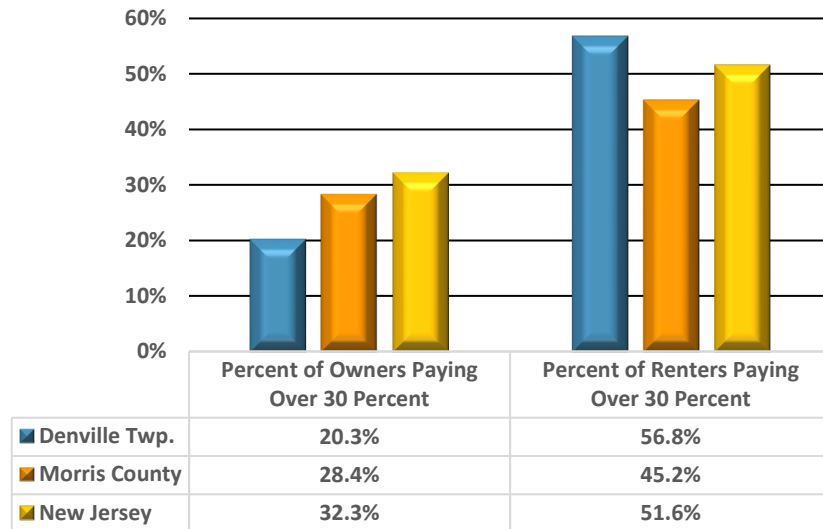

Percent Below Poverty Level

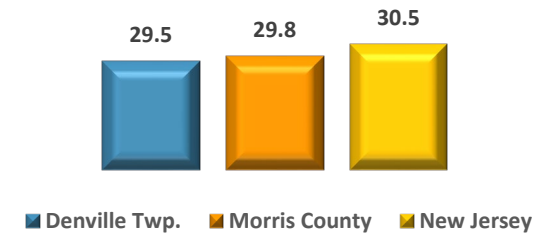
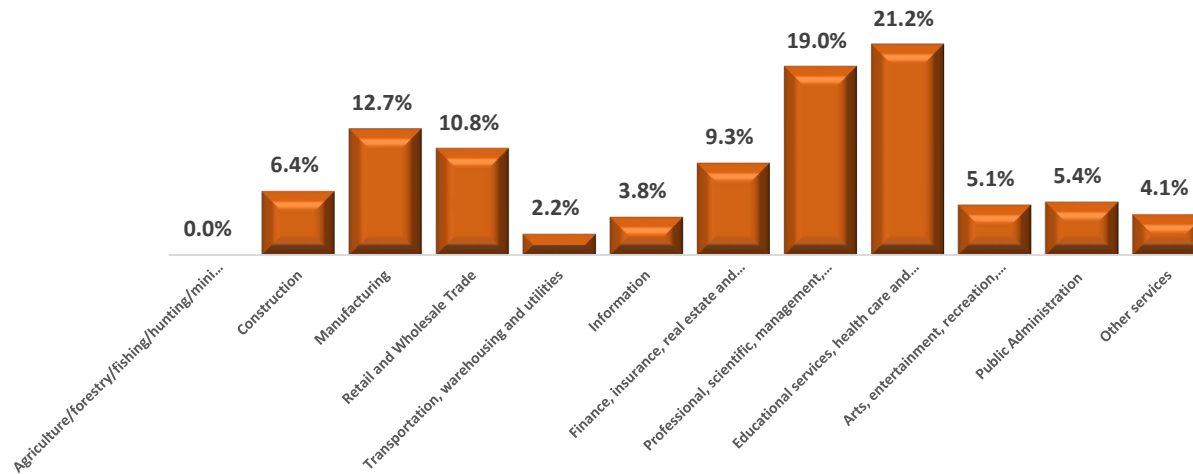

Mean Travel Time to Work (minutes)

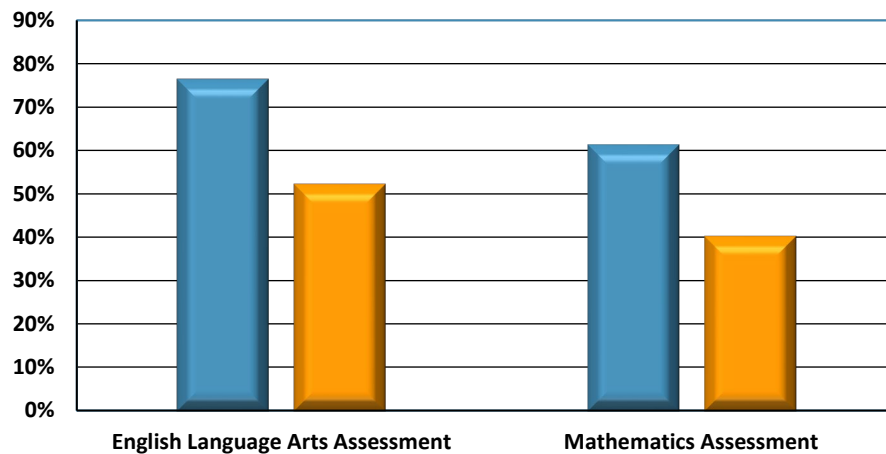

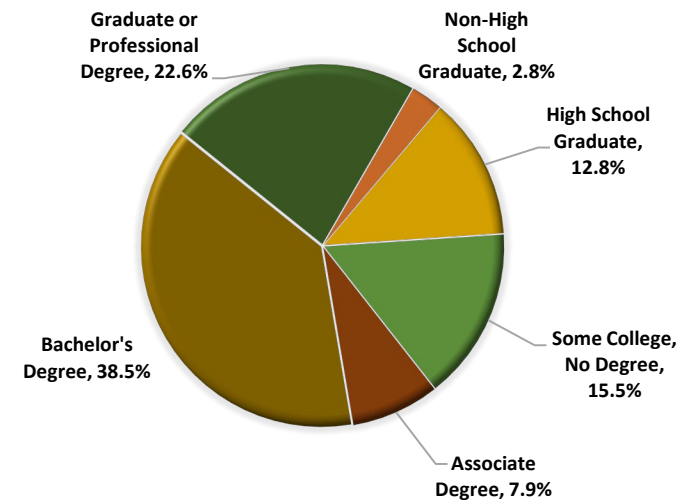
