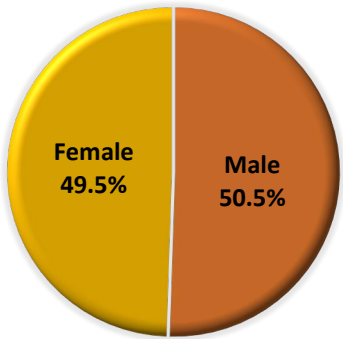
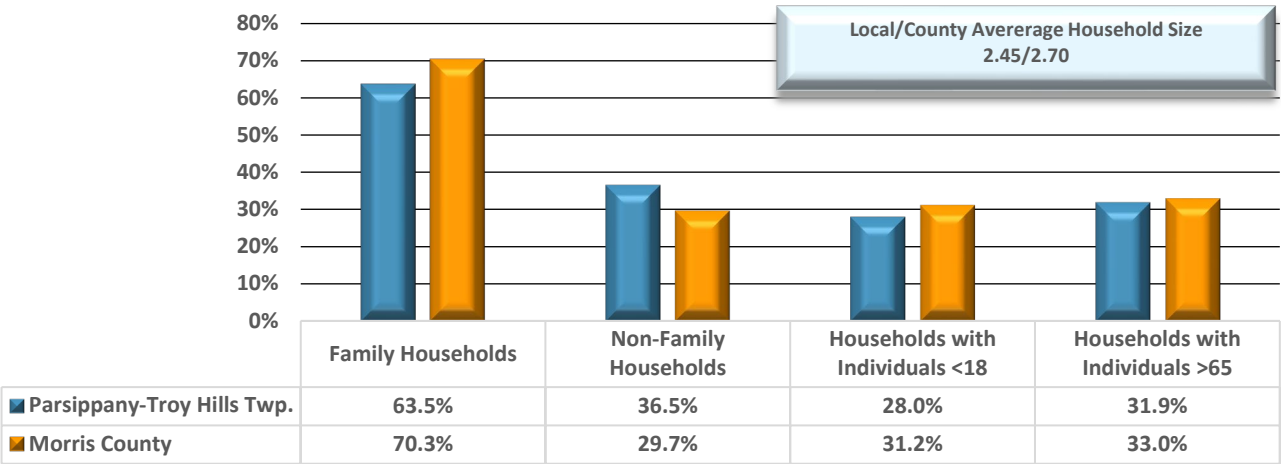

Household Types *Male/Female*

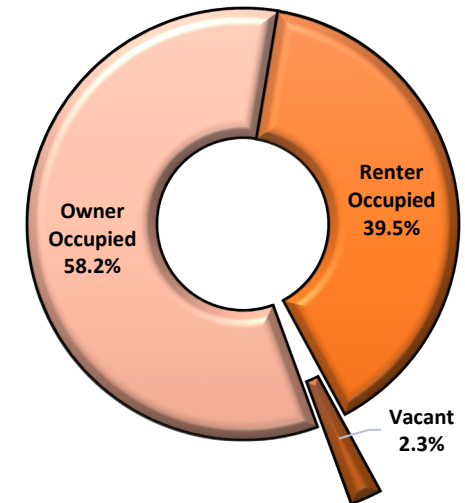
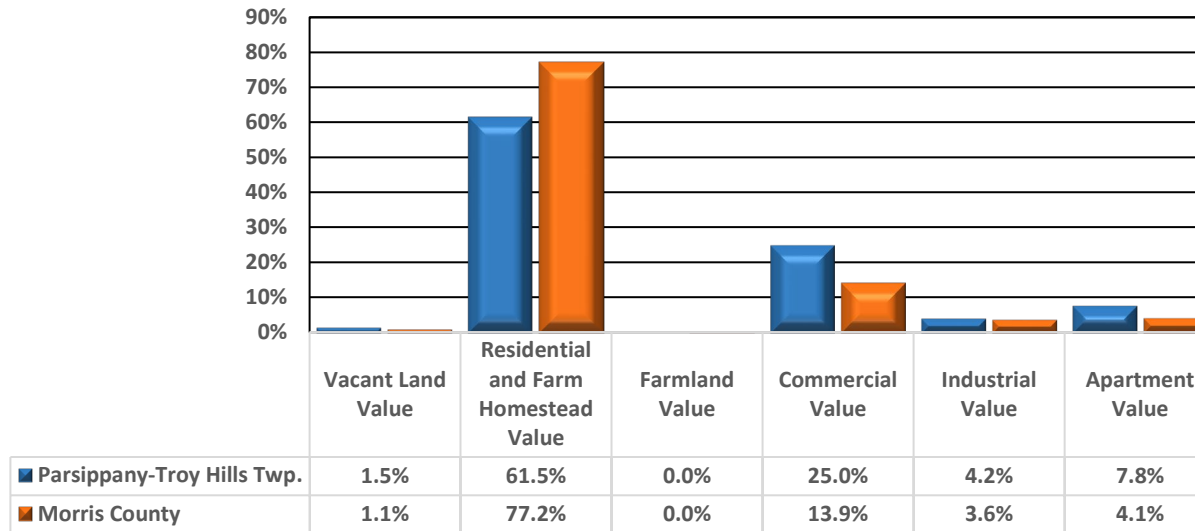

Parcel Values as a Percentage of Total Value

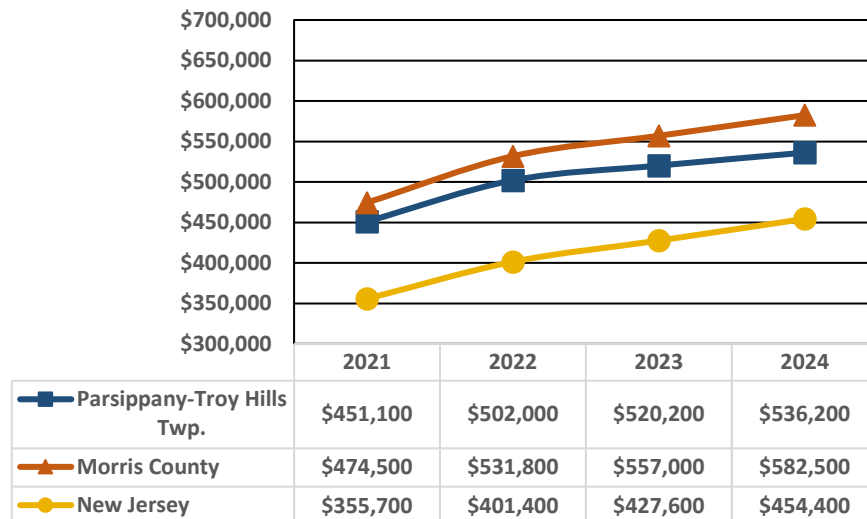
Housing Occupancy



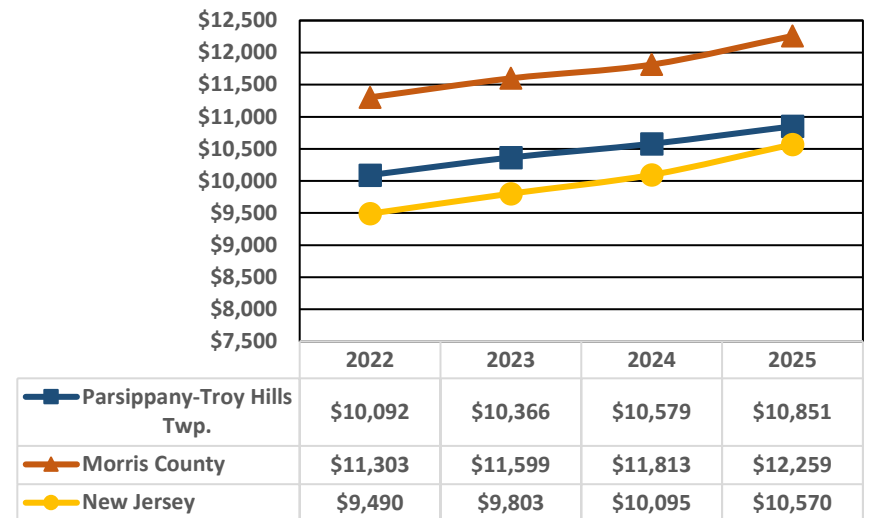

Average Residential Property Tax



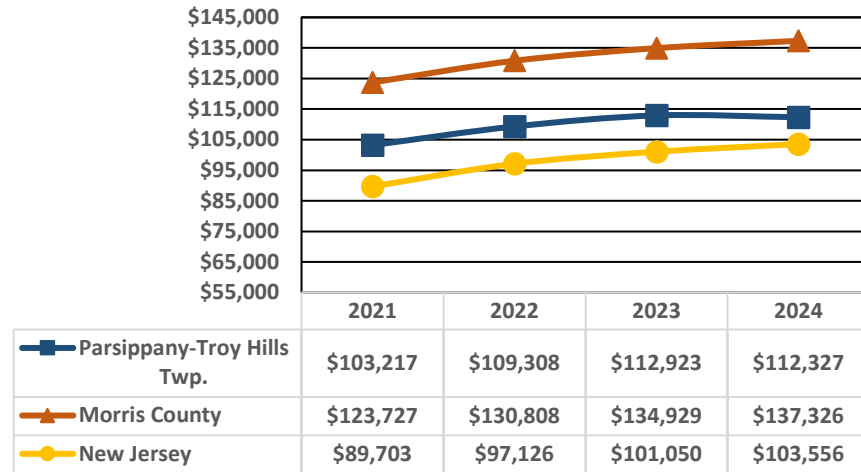

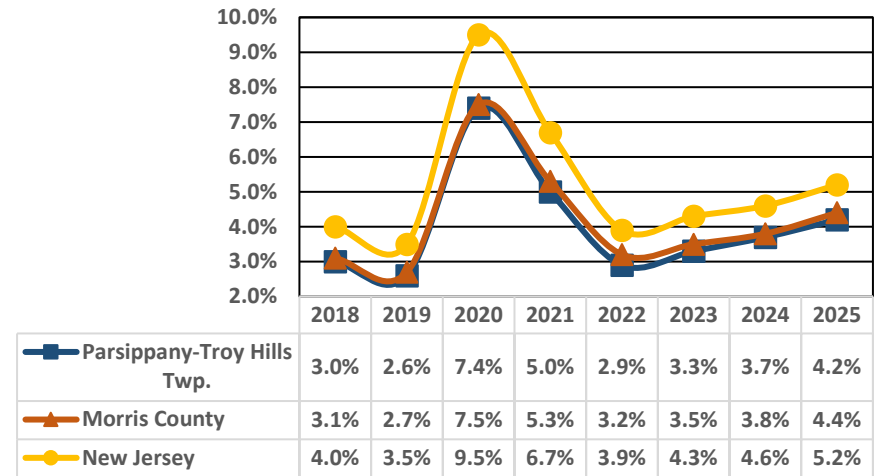

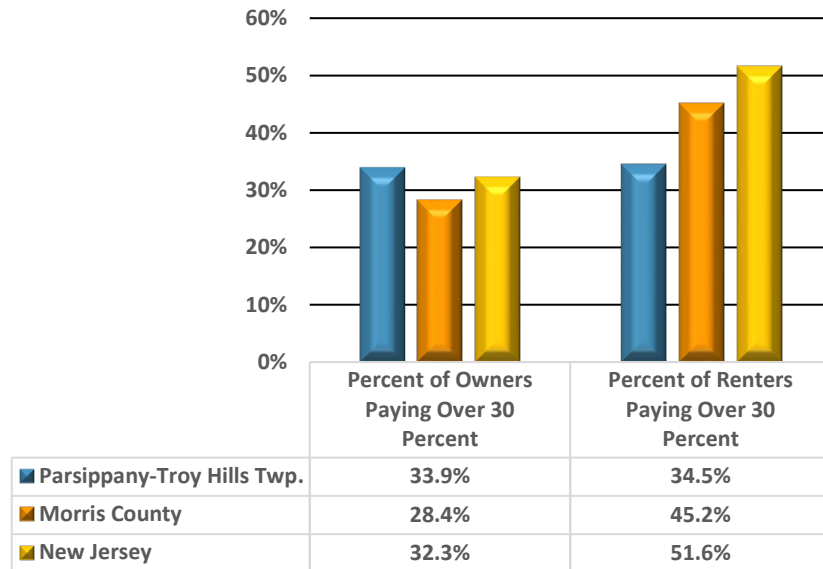

Unemployment Rate



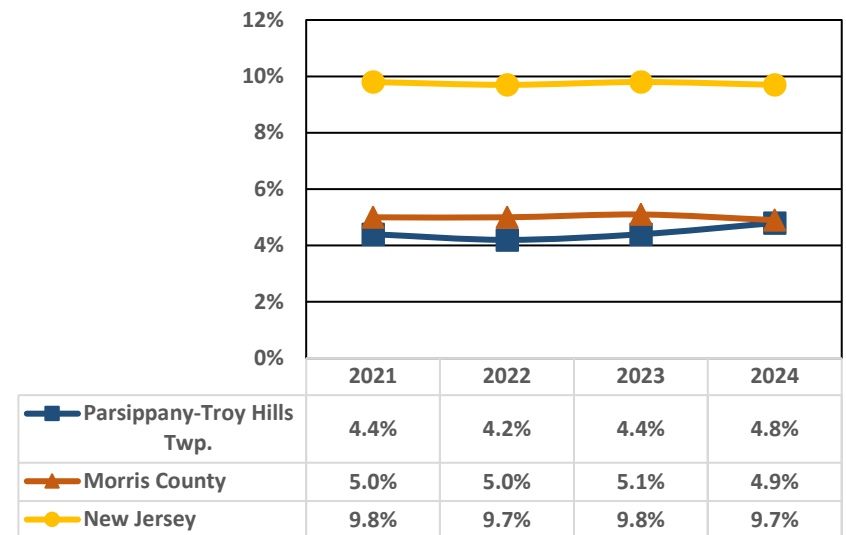

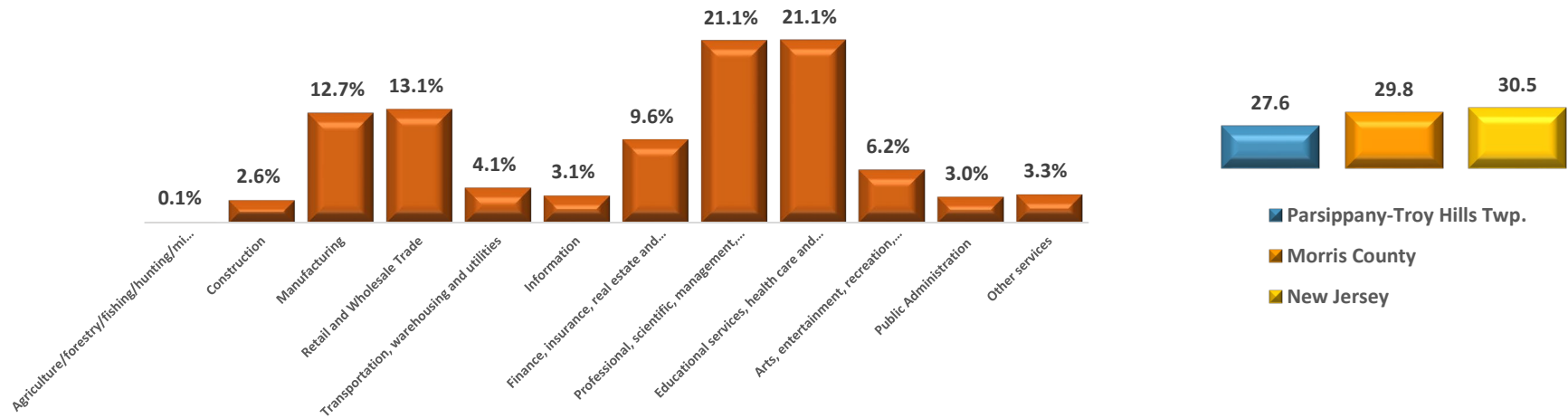
Percent Below Poverty Level

Mean Travel Time to Work (minutes)

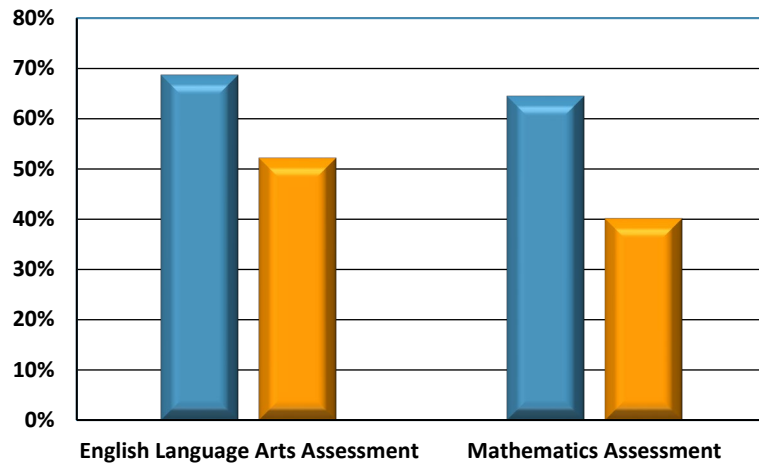

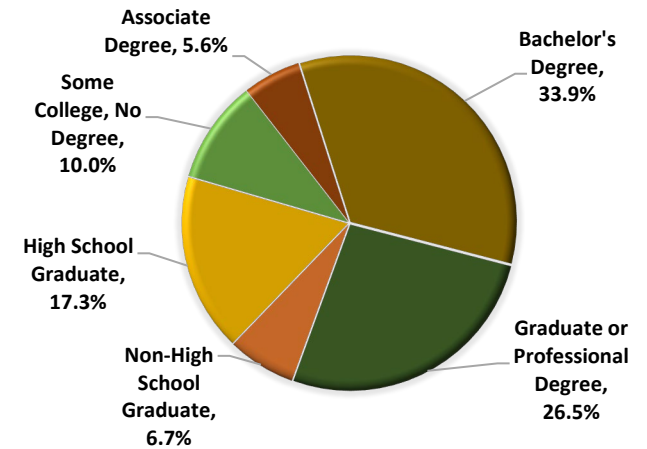
